Heritage Incentives Program

- Provides funding for exterior conservation work to registered heritage properties
- Matching grants of up to \$10,000 for approved projects
- Current version of the Program approved by Regional Council in April, 2004
- 2017/18 budget for the Program was \$150,000



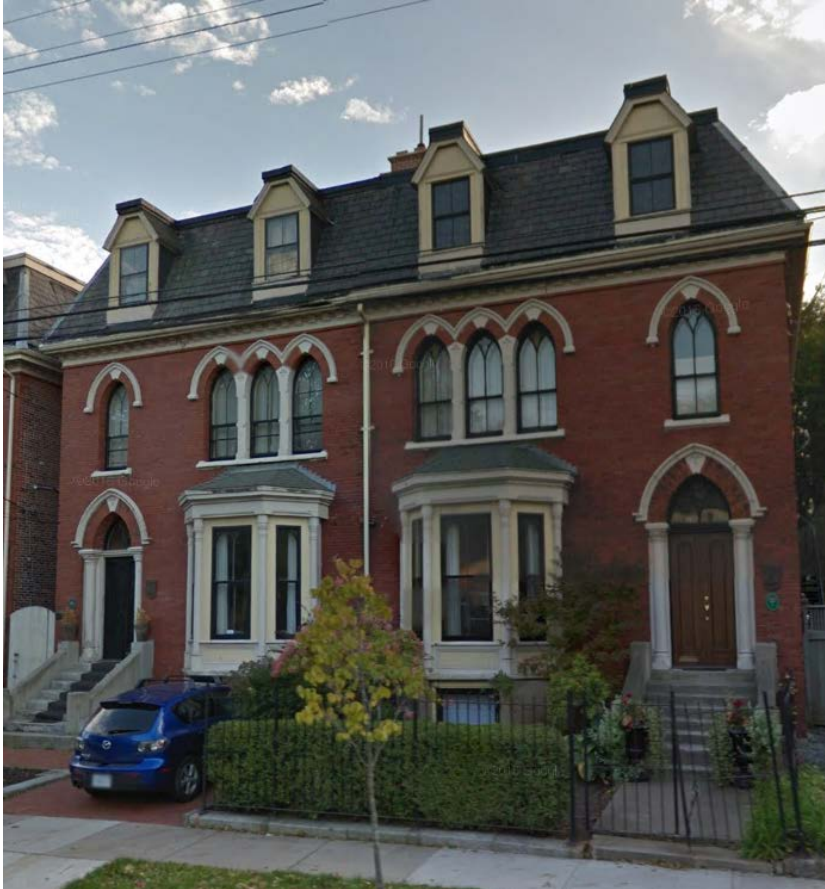

2140 & 2146 Brunswick Street



- Two halves of a semi-detached dwelling under separate ownership
- Both registered heritage properties
- \$7,233 approved for 2140 Brunswick Street in order to support repairs to slate roof

Funding



- Staff were notified that a project approved for \$10,000 will not be moving forward
- No alternative projects have been approved
- Owners of 2146 Brunswick Street have now submitted all required documentation
- Considerable cost is avoided through concurrent repair of the roof
