**SUBJECT:** Stormwater Right of Way (ROW) Reduction

---

## **ORIGIN**

On November 8, 2016, Halifax Regional Council passed a motion:

that Halifax Regional Council direct staff to prepare a report and recommendation with respect to the options and financial implications of providing a reduction of residential taxes for the current 2016/2017 fiscal year for individuals who paid stacked stormwater right-of-way charges (being the owners of approximately 3,724 properties) as described in the discussion section of the staff report dated October 11, 2016 and, as part of the report, staff draft an Administrative Order to implement such reduction, and return to Council for consideration of the resulting report.

## **LEGISLATIVE AUTHORITY**

*Halifax Regional Municipality Charter*, ("HRM Charter") 2008, SNS, c.39, references to estimates, tax rates, area rates, uniform charges, charge by-laws and proceedings for taxes excerpts attached as Attachment 1.

## **RECOMMENDATION**

It is recommended that Halifax Regional Council adopt Administrative Order 2016-008-ADM, the *Tax Reduction Administrative Order*, as set out in Attachment 2 of this report, to provide certain residential properties a one-time tax reduction in April 2017, as set out in the discussion section of this report.

## **BACKGROUND**

In Halifax, Stormwater services were originally provided directly by the municipality and were paid for through a user fee on the water bill. This levy was in addition to the water service and was only paid for by those who had central water, even though the service was provided across the stormwater area. In 2007 Stormwater services (and Sanitary Sewer services) were transferred to Halifax Water and became subject to regulation through the Nova Scotia Utility and Review Board (“NSUARB”).

In 2013, the NSUARB reviewed the rates for stormwater submitted by Halifax Water and approved a site-generated flow charge to pay for the majority of stormwater costs. These rates were to be paid for by all residents and businesses within the Stormwater Service Area, including those not on central water. In addition, because HRM’s roadways cause water runoff, the NSUARB ordered that HRM pay to Halifax Water \$3.9m, annually, towards the cost of Stormwater. HRM is required to pay this money.

In 2013-14, HRM paid this cost using surplus funds that were remaining at the end of the year. On January 14, 2014, however, Halifax Regional Council decided to levy a new Stormwater ROW charge of \$39 per account on those properties that paid the Halifax Water Stormwater Charge, hence using their (site-generated) stormwater methodology. For administrative simplicity, it asked Halifax Water to collect the new Stormwater ROW charge, starting April 1, 2014. Those that paid the Halifax Water charge or were exempted from the charge would also pay or be exempted from the additional HRM charge.

On June 23, 2015, Regional Council discussed alternatives to the HRM Stormwater Charge. It decided to place a flat tax of \$42 (uniform charge) on each taxable property assessment account within the service area, including properties not then paying the Halifax Water charge, i.e. those that had been exempted. The new uniform charge was to be collected on the HRM tax bill, starting in 2016-17. As required by the HRM Charter, all taxable property assessments are subject to the charge. Unlike most of HRM’s taxes, however, the levy was a flat amount (uniform charge).

In the summer of 2016, when the new \$42 per taxable assessment account tax was applied to all HRM properties, a number of unintended consequences appeared:

- More than 800 condo owners, who had previously paid the stormwater charge once for the entire condo building, were now paying the tax on separately deeded properties – condo (dwelling) unit, parking space and/or storage space – that were essentially parts of the same dwelling. (Apartment buildings continued to pay only \$42 per building).
- Likewise, individual mobile homes (in parks) had paid just once per park when on the water bill, similar to apartments. They now had to pay for each mobile home.

As expected, the 4,400 properties that had been exempted from the Halifax Water site-generated charge, and not billed the Stormwater ROW charge, were now paying through their tax bill.

On October 4th, 2016, Regional Council requested a staff report looking at possible changes to the new charge, including reducing the taxes payable on:

- properties that are essentially ancillary to a dwelling, such as parking and storage spaces with separate deed and title [from that of the actual] condominium [unit];
- individual condo owners, where Condominium Corporations were originally billed (\$42);
- [individual mobile homes in] mobile home parks;
- owners having lots which could not be developed; and
- residents previously exempt of the right-of-way fee, before it was moved to the tax bill.

These changes would essentially reverse the decision of June 2015 and again charge residents on the same basis as the Halifax Water site generated flow charge.

On November 8th, 2016, a staff report on Stormwater Right-of-Way Funding Options was provided to Regional Council that outlined three options for the funding of the \$3.9 million charge payable annually to Halifax Water for the stormwater services provided for HRM-owned streets, i.e. HRM rights-of-way. The staff report highlighted the limitations of property taxation and related legislation in creating fine-tuned

criteria for the selection of properties for taxation, concluding that it would be very difficult, if not impossible (or at least impractical) for the Municipality to attempt to duplicate the previous Halifax Water billing through a municipal property tax.

At its November 8<sup>th</sup> meeting, Regional Council asked staff to look at options to refund or reduce 2016-17 taxes for specific property owners, with a specific focus on those who paid twice for one property, specifically, condo owners who had separately-deeded parking or storage spaces, as well as mobile home owners in mobile home parks (land-leased communities). There were additional concerns about other condo owners (in apartment-style condos), who ended up paying considerably more in 2016-17 than in prior years and about those who had been exempted from the Site-Generated Flow charge by Halifax Water.

The challenge in providing a reduction to taxes billed in 2016-17 is that the HRM Charter provides no general ability to provide tax refunds. There is provision to correct billing errors. However, none of these charges was due to a billing error. All of the charges were to taxable assessment accounts in the Stormwater service area.

### **DISCUSSION**

While billing errors can be easily corrected, providing tax refunds when the tax was legally levied and collected is far more problematic.

There is a provision in Section 97 of the Charter that allows for the reduction of residential “taxes payable ...including being retroactive to the beginning of the fiscal year, if the percentage increase in the assessed value of the property... is greater than the percentage prescribed by the policy.” This section of the Charter was not designed to specifically refund taxes already paid and would only apply to about 80% of the stacked charges.

There is more flexibility if the municipality applies the tax reductions in 2017-18. Going forward, the reduction could be applied to all the properties listed in the proposed Administrative Order (Attachment 2). Some low-value properties (i.e. those assessed less than \$4,000) may owe less than \$42 in taxes in 2017-18. The proposed Administrative Order allows any unused portion of the reduction to be carried forward to future years or applied, at the request of the property owner, to another residential property with the same owner. For example, the unused portion of a tax reduction on a parking/storage account could be transferred to the related condo (dwelling unit) account.

Under this recommendation, tax account adjustments would be made in April 2017, rather than March 2017 (given best estimates of administrative resources required). In this way, the tax reduction could be applied to 100% of the properties identified in the proposed Administrative Order. This will allow for easy communication of the process and a highly transparent refund. Revenue and ICT staff are currently system testing to prepare for this implementation approach.

### **FINANCIAL IMPLICATIONS**

The reduction in 2017-18 Stormwater ROW tax revenues of \$156,408 can be funded from the forecast 2016-17 surplus in the Stormwater ROW area rate account, M293.

### **RISK CONSIDERATION**

By granting a tax reduction to some properties, others could request a similar refund. By limiting the reduction to properties experiencing “stacking” and clearly defining “stacking”, the risk is minimized.

### **COMMUNITY ENGAGEMENT**

Those receiving a refund will be notified by HRM tax billing staff through the interim billing process.

### **ENVIRONMENTAL IMPLICATIONS**

There are no environmental implications.

### **ALTERNATIVES**

1. Adopt Administrative Order 2016-008-ADM, the Tax Reduction Administrative Order, and refund the \$42 to the majority of the identified residential properties in the 2016-17 fiscal year (March 2017), being those properties that had any increase in the assessment in the last ten years. The remaining 802 properties would receive a tax reduction of \$42 in the 2017/2018 fiscal year (April 2017). This approach is not recommended due to the potential confusion to property owners and the increased administrative complexity of applying the reductions across two fiscal years. Also, the administrative efficiency (to HRM) and transparency (to property owners) provided through the interim billing process is not realized.
2. Council could refuse to adopt the Administrative Order and, rather than attempting to adjust 2016-17 taxes, Council could focus on improvements to Stormwater ROW charges in 2017-18 and beyond.

Attachment 1  
Excerpts from Halifax Regional Municipality Charter

**Estimates of Required Sums**

93 (1) The Council shall make estimates of the sums that are required by the Municipality for the fiscal year.

(8) The tax rates must be those that the Council deems sufficient to raise the amount required to defray the estimated requirements of the Municipality.

**Tax Rates**

94 The Council shall set separate commercial and residential tax rates for the area of the Municipality determined by the Council to be

- (a) a rural area receiving a rural level of services;
- (b) a suburban area receiving a suburban level of services; and
- (c) an urban area receiving an urban level of services.

**Area Rates and Uniform Charges**

96 (1) The Council may spend money in an area, or for the benefit of an area, for any purpose for which the Municipality may expend funds or borrow.

(2) The Council may recover annually from the area the amount required or as much of that sum as the Council considers advisable to collect in any one fiscal year by an area rate of so much on the dollar on the assessed value of the taxable property or occupancy assessments in the area.

(3) The Council may provide

(a) a subsidy for an area rate from the general rate in the amount or proportion approved by the Council;...

(4) The Council may, in lieu of levying an area rate, levy a uniform charge on each

- (a) taxable property assessment;
- (b) dwelling unit,

in the area.

**Reduction of Tax Increase**

97 (1) The Council may, by policy, to the extent and under the conditions set out in the policy, provide for the reduction of the taxes payable in respect of a residential property in a fiscal year set out in the policy, including being retroactive to the beginning of the fiscal year if the percentage increase in the assessed value of the property averaged over the fiscal year and such number of immediately previous fiscal years as prescribed by the policy is greater than the percentage prescribed by the policy for the fiscal year.

**User charges**

102 Subject to the approval of the Board for those services that are subject to the Public Utilities Act, the Council may, by by-law, prescribe charges for the provision of services for persons who use or benefit from the service, on a basis to be set out in the by-law.

**By-law regarding payment of charges**

104 (1) The Council may make by-laws imposing, fixing and providing methods of enforcing payment of charges for

(a) wastewater facilities or stormwater systems, the use of wastewater facilities or stormwater systems and connecting to wastewater facilities or stormwater systems;

...

(f) laying out, opening, constructing, repairing, improving and maintaining streets, curbs, sidewalks, gutters, bridges, culverts and retaining walls, whether the cost is incurred by the Municipality directly or by, or pursuant to, an agreement with Her Majesty in right of the Province, the Minister of Transportation and Infrastructure Renewal or any person;

**By-law regarding payment of charges**

104 (3) A by-law passed pursuant to this Section may provide

(a) that the charges fixed by, or determined pursuant to, the by-law may be chargeable in proportion to frontage, in proportion to area, in proportion to the assessment of the respective properties fronting on the street or according to another plan or method set out in the by-law.

**HALIFAX REGIONAL MUNICIPALITY  
ADMINISTRATIVE ORDER NUMBER 2016-008-ADM  
RESPECTING THE REDUCTION OF TAXES PAYABLE FOR CERTAIN RESIDENTIAL PROPERTIES**

**BE IT RESOLVED** as an Administrative Order of the Council of the Halifax Regional Municipality, pursuant to section 97 of the *Halifax Regional Municipality Charter*, as follows:

**Short Title**

1. This Administrative Order may be cited as the *Tax Reduction Administrative Order*.

**Interpretation**

2. In this Administrative Order,

(a) “applicable property” means a residential property identified in the schedules attached to this Administrative Order; and

(b) “fiscal year” means the period from April 1<sup>st</sup> in one year to March 31<sup>st</sup> in the following year, including both dates.

**Tax Reduction**

3. This Administrative Order shall be retroactive to April 1, 2016.

4. (1) For the fiscal year 2016/2017, there shall be a reduction in the taxes payable in respect of an applicable property if the percentage change in the assessed value of such property is greater than zero averaged over the 2016/2017 fiscal year and the immediately preceding ten (10) fiscal years.

(2) If subsection 1 of this section applies, there shall be a reduction in the taxes payable on the applicable property for the 2016/2017 fiscal year in the amount of forty-two dollars (\$42).

5. (1) If subsection 1 of section 4 does not apply, there shall be a reduction in the taxes payable in respect of an applicable property of forty-two dollars (\$42) for the 2017/2018 fiscal year.

(2) If subsection 1 of this section applies and the taxes owed to the Municipality on the applicable property for the 2017/2018 fiscal year are less than forty-two dollars (\$42), the tax reduction may, at the request of the owner, be applied to reduce the taxes payable respecting another residential property of such owner.

(3) If subsection 1 of this subsection applies and the taxes owed to the Municipality on the applicable property for the 2017/2018 fiscal year are less than forty-two dollars (\$42) and subsection 2 has not been used, the tax reduction shall apply to subsequent fiscal years until

(a) the end of fiscal year 2021/2022, or

(b) the full forty-two (\$42) has been repaid,

whichever is earlier.
