LEGISLATIVE AUTHORITY

Administrative Order No. 1 – Schedules 1 – 7

The Terms of Reference of the Standing Committees, as approved by Regional Council.

Administrative Order No. 1 – Required Membership of Standing Committees

Section 115 (2) Every Member shall be appointed to a least two Standing Committees.

RECOMMENDATION

- 1. It is recommended that Halifax Regional Council adopt the recommendations of the Standing Committees and Community Council Appointments as outlined in Attachment # 1, to the report dated January 11, 2017.
- 2. It is recommended that Halifax Regional Council rescind the appointment of Councillor Russell Walker as the Halifax and West Community Council representative of the Grants Committee, and appoint Councillor Lindell Smith, as the Halifax and West Community Council representative on the Grants Committee.
- 3. It is recommended that Halifax Regional Council rescind the appointment of Councillor Tony Mancini to the Transportation Standing Committee, and appoint Councillor Richard Zurawski to the Transportation Standing Committee.
- 4. It is recommended that Halifax Regional Council rescind the appointment of Councillor Tony Mancini to the Community Design Advisory Committee as the Transportation Standing Committee representative and appoint Councillor Richard Zurawski to the Community Design Advisory Committee as the Transportation Standing Committee representative.

BACKGROUND/DISCUSSION

Based on the terms of reference of the Standing Committees and Community Councils, as approved by Regional Council, each Committee and Council has the mandate to be the nominating/appointing body (to Regional Council) for the members of a number of Boards and Committees.

Councillor Nominations

Standing Committees and Community Councils of Council met in December, 2016 & January, 2017 to review the expressions of interest put forward by members of Council to serve on the following Boards and Committees:

- Special Events Advisory Committee (One Councillor nominated by and from the Audit & Finance Standing Committee to serve as Chair)
- Special Events Advisory Committee (One Councillor nominated by and from Harbour East-Marine Drive Community Council)
- Active Transportation Advisory Committee (Three Councillors nominated by the Transportation Standing Committee)
- Advisory Committee for Accessibility in HRM (Two Councillors nominated by the Transportation Standing Committee)
- Halifax-Dartmouth Bridge Commission (Two Councillors nominated by the Transportation Standing Committee)

The slate of appointees has been duly vetted and put forward by the Standing Committees and Community Councils and is before Council for formal ratification.

Grants Committee

On December 13, 2016 Councillor Walker was appointed to the Grants Committee twice, once as the Chair by the Audit & Finance Committee, and by Halifax & West Community Council. Upon review, Halifax and West Community Council at their December 14, 2016 meeting passed a motion recommending that Regional Council rescind the appointment of Councillor Walker as the Halifax and West Community Council representative of the Grants Committee, and appoint Councillor Smith.

Standing Committees

As per Administrative Order One Section 115 (2) – "Every Member shall be appointed to a least two Standing Committees".

Councillor Mancini has agreed to step down from the Transportation Standing Committee to allow for Councillor Zurawski to be appointed and be in compliant with Section 115 (2) of Administrative Order One. Attachment two of this report reflects the approved (and proposed) Council appointments to Standing Committees.

FINANCIAL IMPLICATIONS

There are no budget implications to this report that are not already included in the Operating Budget.

A delay in considering and making appointments could result in additional delays for other meeting schedules and business of Committees, as they would be formed at a later date.
