WE, THE UNDERSIGNED PROPERTY OWNERS WITH PARCELS OF LAND WITH ROAD FRONTAGE AND/OR ACCESS FROM LORIANN DRIVE IN PORTERS LAKE, HRM, NS HEREBY PETITION THE HALIFAX REGIONAL MUNICIPALITY AND THE PROVINCE OF NOVA SCOTIA FOR CONSIDERATION OF CAPITAL UPGRADING AND IMPROVEMENT TO OUR ROADWAY FROM A GRAVEL STANDERD TO A PAVED STANDARD WITH THE UNDERSTANDING THIS WILL BE COST-SHARED ON A 50/50 PERCENTAGE BASIS IN ACCORDANCE TO THE NS AID TO MUNICIPALITY PROGRAM FOR PAVING SUB-DIVISION STREETS.

AND FURTHERMORE IT IS UNDERSTOOD THAT WE WILL AGREE TO HAVE A LOCAL IMPROVEMENT CHARGE ASSESSED TO OUR RESPECTIVE PROPERTIES BASED ON PER LOT CHARGE CALCULATED UPON AN ESTIMATED CONSTRUCTION COST OF NO MORE THAN \$30 per LINEAR FOOT OF THE ROADWAY. ACTUAL CONSTRUCTION COSTS WILL BE THE FINAL DETERMINANTS USED TO ASSESS THE LOCAL IMPROVEMENT CHARGE WITH AN ANNUAL ACCURAL INTEREST 2% ABOVE THE PRIME RATE AT THE TIME OF CONSTRUCTION FOR ANY UNPAID ASSESSED BALANCES.
