
Crimes Against Persons 4th Quarter Comparison 2015-2016








Crimes Against Property 4th Quarter Comparison 2015 - 2016

























Halifax District Assaults - Break & Enter - Theft Under October - December 2015/16

Assaults

Assaults Level 1 accounted for 60% of the total <u>Assaults</u> in the 4^{th} quarter of 2016 compared to 63% in 2015 and experienced a +12% **increase** in 2016 over the same period last year.

Assault with a Weapon Causing Bodily Harm accounted for 9% of the total <u>Assaults</u> in 2016 compared to 10% in 2015, and experienced a +17% **increase** in 2016 over the same period last year.

All forms of Sexual Assaults combined accounted for 22% of the total <u>Assaults</u> in 2016 compared to 19% in 2015.

Theft - Other Under \$5,000 accounted for 51% of the total <u>Theft Under \$5,000</u> in the 4th quarter 2016 compared to 58% in 2015 and experienced a -7% **decrease** in 2016 over the same period last year.

Theft from Motor Vehicle under \$5,000 accounted for 46% of the total <u>Theft Under \$5,000</u> in the 4th quarter 2016 compared to 41% in 2015 and experienced a +17% **increase** over the same period last year.

Possession of Stolen Goods under \$5,000 **decreased** by -47% in the 4th quarter of 2016 when compared to the same period last year.

Total District Criminal Code Offences/Drugs

<u>Total Criminal Code</u> offences in the fourth quarter of 2016 show a **decrease** of -15 or by -1.32% compared to the fourth quarter in 2015.

<u>Drugs</u> for the fourth quarter of 2016 **decreased** by -19 or by -20.88% compared to the fourth quarter of 2015.

In the fourth quarter <u>Property offences</u> reported accounted for 50% of Total Criminal Code offences, while crimes against <u>Persons</u> accounted for 13% and <u>Other Criminal Code</u> offences accounted for 37%.

Fourth Quarter comparison between 2015 and 2016:

Property Crimes

Overall Property Crime decreased by -39 or -6.58%.

Stolen Motor Vehicles decreased by -14 or -32.56%.

Break and Enters **decreased** by -29 or -26.13%.

Fraud remained the same at 79 incidents.

Violent Crimes

Overall Violent Crime **increased** by +20 or +15.75%.

Robberies remained the same at 6.

Homicides remained the same at 0.

Attempted Murders **decreased** by -2 or -100%.

Assaults **increased** by +21 or +18.26%.

Assaults accounted for 93% of reported violent crimes in the fourth quarter of 2016.

Other Criminal Code

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (i.e. arson, property damage, indecent acts, counterfeiting currency etc.)

Offensive Weapons decreased by -9 in the fourth quarter of 2016 or -36%.

Moral offences **decreased** by -1 or -100%.

Total District Criminal Code Offences/Drugs

Total Criminal Code offences in 2016 show a **increase** of +28 or by +.61% compared to 2015.

Drugs for 2016 decreased by -29 or -7.97% compared to 2015.

In 2016 <u>Property offences</u> reported accounted for 51% of Total Criminal Code offences, while crimes against <u>Persons</u> accounted for 13% and <u>Other Criminal Code</u> offences accounted for 36%.

Calendar Year comparison between 2015 and 2016:

Property Crimes

Overall Property Crime increased by +181 or +8.42%.

Stolen Motor Vehicles **increased** by +13 or 9.49%.

Break and Enters decreased by -28 or -7.67%.

Fraud incidents **increased** by +55 or +19.93%.

Violent Crimes

Overall Violent Crime **increased** by +14 or +2.48%.

Robberies decreased by -8 or -23.53%.

Homicides decreased by -1 or -33.33%.

Attempted Murders decreased by -1 or 14.29%.

Assaults **increased** by +22 or +4.29%.

Assaults accounted for 93% of reported violent crimes in 2016.

Other Criminal Code

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (i.e. arson, property damage, indecent acts, counterfeiting currency etc.)

Offensive Weapons decreased by -38 in 2016 or by -35.19%.

Moral offences **decreased** by -5 or -100% in 2016.

Total HRM Criminal Code Offences/Drugs

Total Criminal Code offences reported in the fourth quarter of 2016 show a **decrease** of -**183** reported offences or a **decrease** of -**3.79%** compared to the fourth quarter of 2015. Drugs in the fourth quarter of 2016 remained the same at **223** incidents compared to the fourth quarter of 2015.

Property offences account for **50%** of the reported Total Criminal Code offences, while crimes against Persons account for **13%** and Criminal Other offences account for **37%**.

Property Crimes

Property crime shows a **decrease** of **-236** reported offences or **-9.3%**.

Stolen motor vehicles **decreased** by **-18** offences or **-16.82%**.

Break and Enters decreased by -64 offences or -19.16%.

Frauds decreased by -75 offences or -21.55%.

Violent Crimes

Violent crime experienced an **increase** in the fourth quarter of 2016 compared to 2015 by +**55** offences or a change of +**9.65%**.

Robberies decreased by -5 offences or a change of -9.62%.

Homicides **increased** by +3 in the fourth quarter in 2016 compared to the fourth quarter of 2015.

Attempted murders **decreased** by -7 or -100% in 2016 compared to the fourth quarter of 2015.

Assaults **increased** by +63 offences or a change of +12.63%. Assaults accounted for 90% of violent crimes in the fourth quarter of 2016.

Criminal Other

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (arson, property damage, indecent acts, counterfeiting, etc.) has **decreased** by **-2** or **-0.12%**.

Prostitution offences decreased by -14 offences in the fourth quarter of 2016 over 2015 or -100%.

Please note offences such as drug and prostitution are sensitive to directed enforcement and detection.
