**Motion for North West Community Council to Consider:** 

That North West Community Council recommend that Halifax Regional Council authorize the following one-time Community Grants to be funded from the LWF Ratepayers Association Common Area Rate:

- \$30,000.00 to the Shubenacadie Watershed Environmental Protection Society for the construction of the Holland Coach Trail, Sports Park Connector, and Portobello Connector
- \$5,000.00 to the Riverlake Scout Group to install replacement windows and vandalism deterrents, complete a fire inspection and repair the roof and soffits for a watertight cabin and;
- \$15,000.00 LWF Minor Baseball to cover the cost of replacement baseball lights at the Dan Franklin Memorial Field.

#### Reason:

On July 18, 2017 Halifax Regional Council approved the following motion with respect to Community Grants funded from the LWF Ratepayers Association Common Area Rate:

That Halifax Regional Council maintain the area rate for LWF Ratepayers Association at \$0.03 per \$100.00 of residential and resource assessment with the budget for grants to be subject to approval by the North West Community Council.

- Girl Guides and other Community groups started using the WJCC bldg. in the winter months for the first time ever.
- LWF RA funding allowed the WJCC to install a new septic system and other infrastructure improvements.

Dear Tim,

It took us a while to get here, but the HRM Department of Financial Policy and Planning has outlined the process required to expend the LWFRA Community Grants. As passed by Council on July 18<sup>th</sup>, "the budget for grants to be subject to approval by the North West Community Council."

The annual expenses listed in our budget will be processed as usual, with no changes to the previous process.

Those expenses budgeted under Community Grants (\$128,400), require the additional step of being approved through North West Community Council.

As outlined by HRM Department of Financial Policy and Planning, you will find attached to our letter a brief description of each grant request. In our meeting of February 20, 2018 the LWFRA approved \$50,000 in funding to SWEPS Trailway, 1<sup>st</sup> Riverlake Scouts and LWF Minor Baseball. Our discussions with HRM Department of Financial Policy and Planning indicate that this is sufficient as a report for your purposes.

## **SWEPS Trailway**

The Shubenacadie Watershed Environmental Protection Society – Trails division requested \$30,000 toward the detailed design plans for construction of the Holland Coach Trail, Sports Park Connector, and Portobello Connector. These are the local pieces of the active transportation trail from Portobello to Carroll's Corner. The funding request compliments confirmed funds from private funders and HRM.

The project was evaluated by 8 members of the LWFRA and scored an 85%. The motion was approved to fund the full request of \$30,000.

The 1<sup>st</sup> Riverlake Scout Group has requested \$5,000 to install replacement windows and vandalism deterrents, complete a fire inspection and repair the roof and soffits for a watertight cabin. The funding requested compliments donations of material. The 1<sup>st</sup> Riverlake Scouts serve the local area, including the catchment area. The funding request compliments a donation of materials and earned revenue from Christmas tree sales in Fall River.

The project was evaluated by 9 members of the LWFRA and scored an 94%. The motion was approved to fund the full request of \$5,000.

LWF Minor Baseball has requested \$15,000 to cover the cost of replacement baseball lights at the Dan Franklin Memorial Field. The funding requested completely upgrades the field lighting. Lights on the baseball field are used 5-7 days/week May-October.

The project was evaluated by 8 members of the LWFRA and scored an 97%. The motion was approved to fund the full request of \$15,000.
