Subject: Seniors Snow Removal Program Update		
Motion for Council to Consider: That Halifax Regional Council request that Information Report Item 2 - Seniors Snow Removal Program Update - be added as a regular agenda item for discussion. In addition, that Halifax Regional Council direct staff to find the necessary resources of \$61,500 to fund the remaining waiting list of 71 clients for this winter season. Reason: The Seniors Snow Removal Program reached its capacity and now has an extensive waiting list. Additional funding is required to make the program available to the citizens who are not currently receiving services. Outcome Sought: Council directs staff to find an additional \$61,500 to fund the Senior Snow Removal Program this year.

SUBJECT: 2015-2016 Snow Removal Program for Seniors and Persons with Disabilities.

INFORMATION REPORT

ORIGIN

On November 24, 2015 Regional Council passed a motion requesting a staff information report in regards to the status, wait list and possible funding requirements of the 2015-2016 Snow Removal Program for Seniors and Persons with Disabilities.

LEGISLATIVE AUTHORITY

Section 79(1)(av)(vii) of the HRM Charter permits the Municipality to expend funds on a grant or contribution to a registered Canadian charitable organization.

BACKGROUND

The Seniors' Snow Removal Assistance Program pre-dated amalgamation in the former City of Halifax. The program, since its inception, has always been about snow removal on private property, administered by a charitable organization for specified individuals with specific needs. The program includes snow removal on: front steps, back steps, front walkways, a pathway to the oil tank and sidewalk, if required.

In 2006, there was a desire from Regional Council to extend sidewalk snow clearing service to include main arterial and transit routes on the peninsula. At that time, as an alternative, staff proposed servicing main arterials and transit routes on the peninsula and increasing the funding to the Seniors' Program to \$360,000 as part of the winter sidewalk service for main arterial and transit routes on the peninsula. This recommendation was subsequently approved and in December 2009 funding was approved to the current level of \$400,000, in order to reduce the waiting list.

On August 5, 2014 Regional Council approved a multi-year agreement with the Halifax YMCA to administer the Seniors' Snow Removal Assistance Program, subject to annual budget approval, which would allow for stability and confidence with residents and provide the YMCA a strong foundation for increased service delivery through efficiencies of a multi-year program.

DISCUSSION

The YMCA delivers the day to day operation of this program on behalf of the community at large with funding from HRM. Membership in the program is also administered by the YMCA.

Currently there are 455 approved clients on the Seniors' Snow Removal Program. There was \$3,090 in funding remaining from the 2014/2015 contract year and that combined with the \$400,000 for the 2015/2016 contract year is a total of \$403,090. The current cost per client is \$650 + 7.5% HST, plus if the snow fall exceeds 212 cm of snow for the season there is an extra cost per client of \$50 + 7.5% HST. The YMCA Administration fee is \$60,000 to administer the program.

As of the 5 January 2016 there were approximately 71 potential clients on the wait list. A large number of applications have been sent out this year. This would bring the total enrolment in the program to 526 clients.

* Charities can claim a rebate of 50 percent of the GST/HST paid or owing on eligible expenses.

FINANCIAL IMPLICATIONS

Funding for the annual snow removal program in the amount of \$400,000 is available in the approved 2015/16 operating budget in Account R885 – 6310 West Sidewalk Snow and Ice Control.

In addition, the YMCA has a carry over balance of \$3,090 from 2014/15 fiscal.

An additional cost of \$61,441 would be required to expand the program to 71 additional clients. This additional funding is not currently within TPW's envelope.
