**SUBJECT:** North West Community Council – 2018 Annual Report

### **ORIGIN / LEGISLATIVE AUTHORITY**

Section 27(1) of the HRM Charter states:

A community council shall hold an annual public meeting in the community in each year to report to the public concerning its activities and to receive the views of the public respecting all matters within its mandate. The powers and duties of Community Councils are outlined in section 25 of the HRM Charter.

North West Community Council requested that the Legislative Assistant maintain a record of the Community Council's business for the first annual meeting held in 2013 and annually held thereafter.

### **BACKGROUND**

North West Council was established on December 3, 2012 by Administrative Order 48, Respecting the Creation of Community Councils.

North West Community Council includes the following districts:

District 1: Waverly – Fall River – Musquodoboit – (Councillor Steve Streatch)

District 13: Hammonds Plains – St. Margaret's Bay – (Councillor Matt Whitman)

District 14: Middle/Upper Sackville - Beaver Bank - Lucasville - (Councillor Lisa Blackburn)

District 15: Lower Sackville – (Councillor Steve Craig)

District 16: Bedford -Wentworth - (Councillor Tim Outhit)

### **RECOMMENDATION**

That North West Community Council accept and table the 2018 Annual Report as presented.

### **DISCUSSION**

North West Community Council met eleven (11) times between December 11, 2017 and November 5, 2018 in various locations within the five districts. Meeting locations for 2018 included Acadia Hall, 650 Sackville Drive, Lower Sackville, the Bedford-Hammonds Plains Community Centre, 202 Innovation Drive, Bedford and the Goffs Fire Hall (Station 47) 2040 Old Guysborough Rd. Goffs. A joint special meeting of Halifax and West Community Council, Harbour East-Marine Drive and North West Community Council was held September 18, 2018 in the Council Chamber, 3<sup>rd</sup> Floor City Hall, 1841 Argyle Street, Halifax.

December 7, 2017 - Case 20907: Amendment to the R-6 (Rural Residential) Zone of the Sackville Land Use By-law to permit pet care facilities in conjunction with a dwelling

Motion approved that North West Community Council adopt the amendments to the Land Use By-law for Sackville, as set out in Attachment A of the staff report dated October 10, 2017.

# January 8, 2018 - Case 20332: Development Agreement, Sackville Drive, Middle Sackville (PID 41158858)

Motion approved that North West Community Council:

- 1. Approve the proposed development agreement, which shall be substantially of the same form as set out in Attachment A of the staff report dated September 27, 2017; and
- 2. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council

and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

# February 12, 2018 - Case 18475: Amendment to the Land Use By-law for Planning Districts 14 & 17 (Shubenacadie Lakes) to enable Accessory Outdoor Display Courts under the AE-2 (General Airport) Zone

Motion approved that North West Community Council adopt the amendment to the Land Use By-law for Planning Districts 14 & 17 (Shubenacadie Lakes), as set out in Attachment A of the staff report dated December 21, 2017.

# May 14, 2018 - Case 21012: Development Agreement for reduction in Environmental Setback, Damascus Road and Duke Street. Bedford

Motion approved that North West Community Council:

- 1. Approve the proposed development agreement, which shall be substantially of the same form as set out in Attachment A of the staff report dated March 28, 2018; and
- 2. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

## Case 20975: Substantive Amendment to Development Agreement for 540 Southgate Drive, Bedford

Motion approved that North West Community Council

- 1. Approve the proposed amending development agreement, which shall be substantially of the same form as set out in Attachment A of the staff report dated February 15, 2018; and
- 2. Require the amending development agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

# July 9, 2018 - Case 21094: Development Agreement Discharge and Land Use By-law amendment for Clearwater Seafoods, 757 Bedford Highway, Bedford

Motion approved that North West Community Council adopt the amendment to the Land Use By-law for Bedford, as set out in the revised Attachment B of the staff report dated April 5, 2018.

#### September 10, 2018 - Case 21564: Rezoning of 65 Halfway Lake, Hammonds Plains

Motion approved that North West Community Council adopt the amendment to the Land Use By-law for the Beaver Bank, Hammonds Plains and Upper Sackville Plan Area, as set out in Attachment A of the staff report dated June 18, 2018.

### Case 21099: Development Agreement for Fourth Street, Bedford

Motion approved that North West Community Council:

- 1. Approve the proposed development agreement, which shall be substantially of the same form as set out in Attachment A of the staff report dated June 15, 2018; and
- 2. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever; otherwise this approval will be void and obligations arising hereunder shall be at an end.

#### Variance Appeals

December 17, 2017 - Case 21137: Appeal of Variance Approval - PID No. 41074493, Rocky Lake Drive. Bedford

Motion approved that North West Community Council allow the appeal of the Variance approval for PID No. 410744493, Rocky Lake Drive, Bedford.

# October 1, 2018 - Case 21429: Appeal of Variance Approval - PID No. 40304198, St. Margaret's Bay Road, Head of St. Margaret's Bay

The following motion was <u>defeated</u>: That North West Community Council allow the appeal. (Decision of the Development Officer to approve the variance was upheld).
