• Nova Scotia Solid Waste-Resource Management Regional Chairs Committee (Two Councillors nominated by Environment & Sustainability Standing Committee)

The slate of appointees has been duly vetted and put forward by the Standing Committees and Community Councils and is before Council for formal ratification.
