LEGISLATIVE AUTHORITY

Administrative Order No 1 – Schedule 2 & 8

The Terms of Reference of the Audit and Finance Standing Committee and the Community Councils Rules of Governing Procedures, as approved by Regional Council.

RECOMMENDATION

It is recommended that Halifax Regional Council appoint Councillor Blackburn to the Special Events Advisory Committee as the representative from North West Community Council.

BACKGROUND/DISCUSSION

Based on the terms of reference of the Standing Committees and Community Councils as approved by Regional Council, each Committee has the mandate to be the nominating/appointing body (to Regional Council) for the members of a number of Boards and Committees.

Councillor Nominations

The North West Community Council met on January 14, 2019 to review the expressions of interest, and put forward by members of Council to serve on the **Special Events Advisory Committee** (One Councillor nominated by and from the Harbour East Marine Drive Community Council item 14.7.1 and North West Community Council Member recommendation made on January 14, 2019). Councillor Blackburn has been duly vetted and put forward by the North West Community Council until November 30, 2020, and is before Council for a formal ratification. Councillor Adams was appointed by the Audit and Finance Standing Committee as Chair of the Special Events Advisory Committee and also represents the Halifax and West Community Council.
