SUBJECT: Daffodil Garden for Cancer, Ferry Terminal Park

ORIGIN

Harbour East-Marine Drive Community Council October 4, 2018 meeting, Items 11.3.2 and 13.2.1
Harbour East-Marine Drive Community Council January 10, 2019 Meeting, Item 16.1.

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter, section 25 which states:

“The powers and duties of a community council include:

(a) monitoring the provision of services to the community and recommending the appropriate level of services, areas where additional services are required and ways in which the provision of services can be improved;”

RECOMMENDATION

The Harbour East-Marine Drive Community Council recommends that Halifax Regional Council authorize staff to undertake the development of a Daffodil Garden for Cancer at Ferry Terminal Park in Dartmouth, pending the provision of full funding for the project as per the Financial Implications sections of the staff report dated January 2, 2019.

BACKGROUND

The Harbour East-Marine Drive Community Council received a presentation (Item 11.3.2) at their October 4, 2018 meeting from resident Judie Edgar on their vision to create a greenspace to give hope and courage to the many people that survive cancer. Edgar proposed the park be located at the Dartmouth Harbourfront, between Alderney Ferry Terminal and King's Wharf, and pending approval the park be named the "Cancer Survivors Daffodil Park". The Community Council approved a motion at their October 4, 2019 meeting (Item 13.2.1) to request a staff report examining the creation of a Cancer Survivors Park in Dartmouth Harbourfront, between Alderney Ferry Terminal and King's Wharf.

The Harbour East-Marine Drive Community Council received a staff report dated January 2, 2019 at their January 10, 2019 outlining staff's review of the proposal for a Daffodil Garden for Cancer.

Additional information can be reviewed in the attached staff report dated January 2, 2019.

DISCUSSION

The Harbour East-Marine Drive Community Council reviewed the January 2, 2019 staff report at their January 10, 2019 meeting, with a point being made about having 'Survivor' included in the park name. The Community Council approved a motion authorizing staff to undertake the development of a Daffodil Garden for Cancer at Ferry Terminal Park in Dartmouth, pending the provision of full funding for the project as per the Financial Implications section of the staff report.

Subsequent to the January 10, 2019 Harbour East-Marine Drive Community Council meeting, it was determined that there are budgetary implications associated with this development that require Halifax Regional Council approval.

SUBJECT: **Daffodil Garden for Cancer, Ferry Terminal Park**

ORIGIN

October 4, 2018 - Harbour East-Marine Drive Community Council motion:

MOVED by Councillor Nicoll, seconded by Councillor Karsten

THAT Harbour East-Marine Drive Community Council request a staff report examining the creation of a Cancer Survivors Park on the Dartmouth Harbourfront, between the Alderney Ferry Terminal and King's Wharf.

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter, S.N.S. 2008, c.39

- 79 (1) The Council may expend money required by the Municipality for:
- (ai) public grounds, squares, halls, museums, parks, tourist information centres and community centres

RECOMMENDATION

It is recommended that Harbour East-Marine Drive Community Council authorize staff to undertake the development of a Daffodil Garden for Cancer at Ferry Terminal Park in Dartmouth, pending the provision of full funding for the project as per the Financial Implications section of this report.

BACKGROUND

What is a Cancer Survivors garden?

Cancer Survivors gardens, or parks as they are sometimes called, are designed to create an inspirational retreat that provides a place for understanding, accepting and enjoying survivorship. Cancer survivors gardens have been established in 25 cities in Canada and the United States. Two of these are in Ontario; one in Ottawa was created in 2008 and one in Mississauga was created in 2006.

Proposal

Dartmouth residents, Jim and Judie Edgar, have been working to establish a Cancer Survivors Park in the Halifax Regional Municipality, as a green space to give hope and courage to the many people that survive cancer.

On October 4, 2018 Judie and Jim Edgar presented to the Harbour East-Marine Drive Community Council their vision to create an inspirational retreat that would provide a place for understanding, accepting and enjoying survivorship. A copy of their presentation is attached to this report as Attachment 3.

The Edgar's reviewed site considerations for the proposed park and their preferred location is along the Dartmouth Harbour Walk, located between Alderney Ferry Terminal and King's Wharf.

The Edgars are currently working with the Canadian Cancer Society to raise funds for this project. This funding may be supplemented by contributions by individual councillors through district capital.

DISCUSSION

Location

The proposed location for this installation, within Ferry Terminal Park, across from Prince Street was requested by the Edgar's. Staff has reviewed the selected site and agree that it is an acceptable location (refer to Attachment 2). Other sites within HRM were not assessed for this project.

The developers of King's Wharf are reviewing options with HRM for an emergency access near Alderney Drive in the vicinity of Prince Street and King Street. HRM Development Engineering was consulted and determined that the proposed Daffodil Garden for Cancer location would not conflict with the emergency access infrastructure.

Naming

In the presentation to Harbour East-Marine Drive Community Council, the project was titled the "Cancer Survivors Park". This name cannot be approved under the HRM Asset Naming Policy (Administrative Order Number 46) as the site is currently located within Ferry Terminal Park, and would therefore be considered a park feature within an existing park. In discussions with the HRM Asset Naming Committee, it has been suggested that if the garden is developed, it would be classified as a garden park feature and use a horticultural name to define it.

HRM's Asset Naming Policy allows any person or group to apply for a commemorative name for HRM assets (including park features) and one of the criteria is "requested name recognizes the flora and fauna of the local area". Therefore, the name "Daffodil Garden for Cancer" could be considered for the garden feature under that criteria.

Features

This proposed project consists of construction elements and materials which can be considered as standard park assets, such as a concrete sidewalk, park benches, a park sign, and planting beds with perennials and shrubs. Other elements of the installation would be considered as specialized assets including a concrete statue and plaques with engraved quotations (refer to attachment 1). The content of the quotations would need to be approved by HRM staff prior to installation.

Construction

If sufficient funding is realized, HRM will issue a public tender for the construction with an anticipated completion date of early June prior to the Provincially designated Cancer Survivors' Day which is held on the first Sunday in June. HRM will administer the tender, award and construction process.

Maintenance

The elements which are standard to parks (sidewalk, park benches, sign and planting beds) will be maintained by HRM Parks & Recreation. The maintenance of the specialized assets (statue and plaques) may be funded for the first three years through a dedicated fund to be set aside by the Canadian Cancer Society, pending fundraising efforts. After this time, HRM will be responsible for all ongoing maintenance.

FINANCIAL IMPLICATIONS

This project is currently included in the proposed 2019/20 Capital Budget from Project Account No. CP180001 – Park Recapitalization. This project is estimated at \$50,000 (gross) with no net cost to HRM, with funding from donations administered by the Canadian Cancer Society. Funding may also be supplemented by contributions from individual councillors through district capital. The Proposed 2019/20 Capital Budget also includes \$3,000 for Ongoing Operating Costs Associated with Capital (OCC).

The project will not proceed to tender and construction until the required external funding has been secured by HRM.

RISK CONSIDERATION

There are no significant risks associated with the recommendations of this report. The risk consideration rate is low. To determine this consideration was given to operational, financial and reputational risks.

COMMUNITY ENGAGEMENT

The scale of this park feature does not warrant community consultation.

ENVIRONMENTAL IMPLICATIONS

Environmental Implications not identified.

ALTERNATIVES

Community Council may choose to recommend that Halifax Regional Council not approve this project.

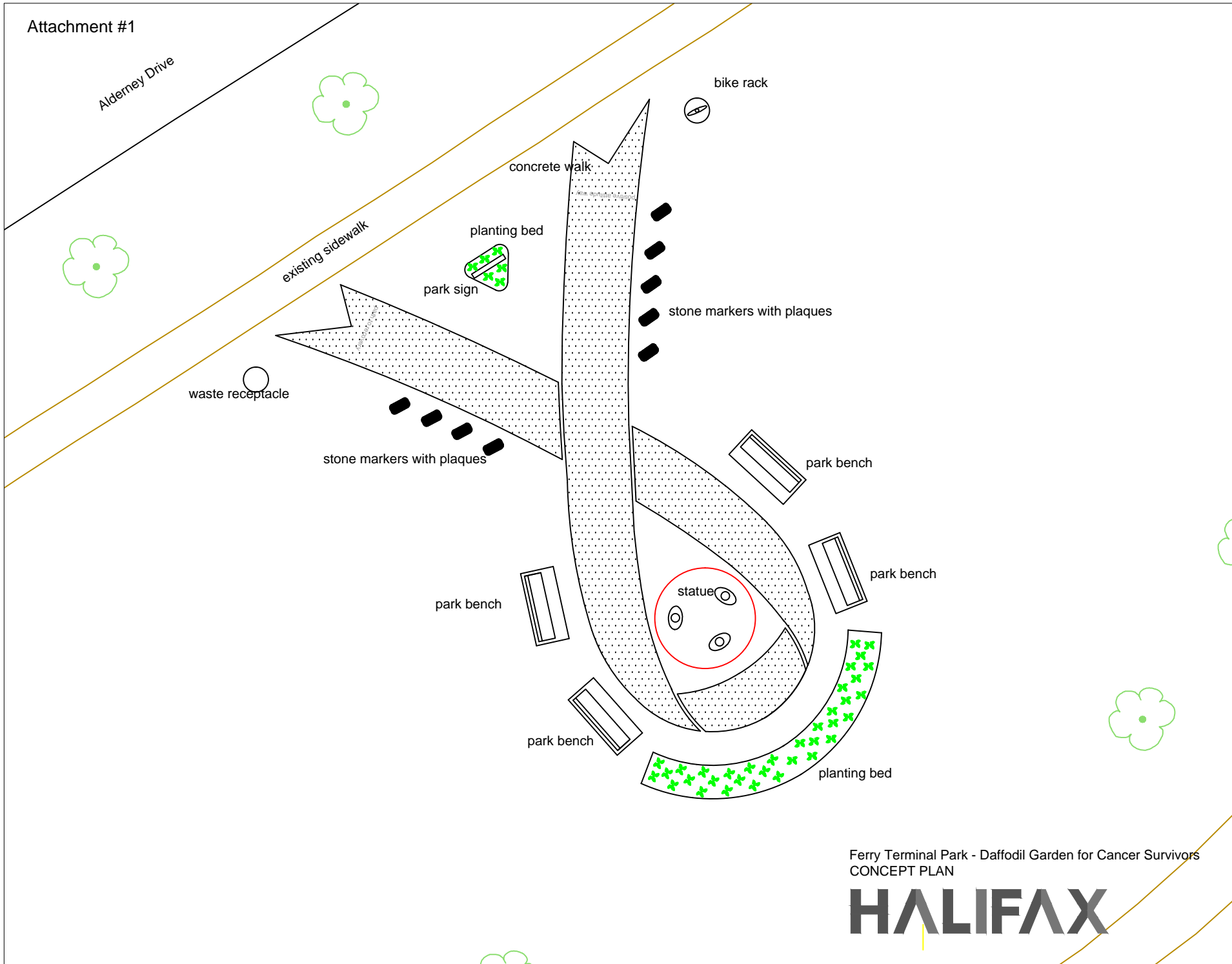

Reason: The Cancer Survivors Park would be a daily reminder to all who pass by with a message to the subconscious that death and cancer are not synonymous. The message and park are meant to give hope and courage.

Greenbelt area:

Reason: An environmentally friendly and tranquil spot to remind us that people survive this disease and will continue to do so.

MISSION ACCOMPLISHED!!!

Dartmouth Harbourwalk

The proposed park would be located between Alderney Ferry Terminal and King's Wharf. It will directly connect to the Trans Canada Trail, HRM's park system, biking and walking trails, and complement the continued development of downtown Dartmouth as a destination.

Important Components of the Park

- ❑ The concrete path through the park area would be in the shape of a ribbon which represents cancer awareness. It would not be tinted in any colour linking to a specific type of cancer as this park will represent cancer survivors of ALL types of cancers.
- ❑ The preferred name of the park (pending approval) would be “*Cancer Survivors Daffodil Park*”. The daffodil is the flower of the Canadian Cancer Society that symbolizes rebirth and new beginnings which embodies survivorship. It is such a resilient flower that starts as a bulb thriving through the cold winter to break through in spring as a beautiful yellow flower. It represents hope in the fight against cancer.
- ❑ The artistic feature will be located in the loop of the ribbon and consist of three life sized figures representing youth, middle age and senior population as cancer does not discriminate when it come to age. We hope to have them interactive to make a great photo op and memory of the visit.

KNOWLEDGE

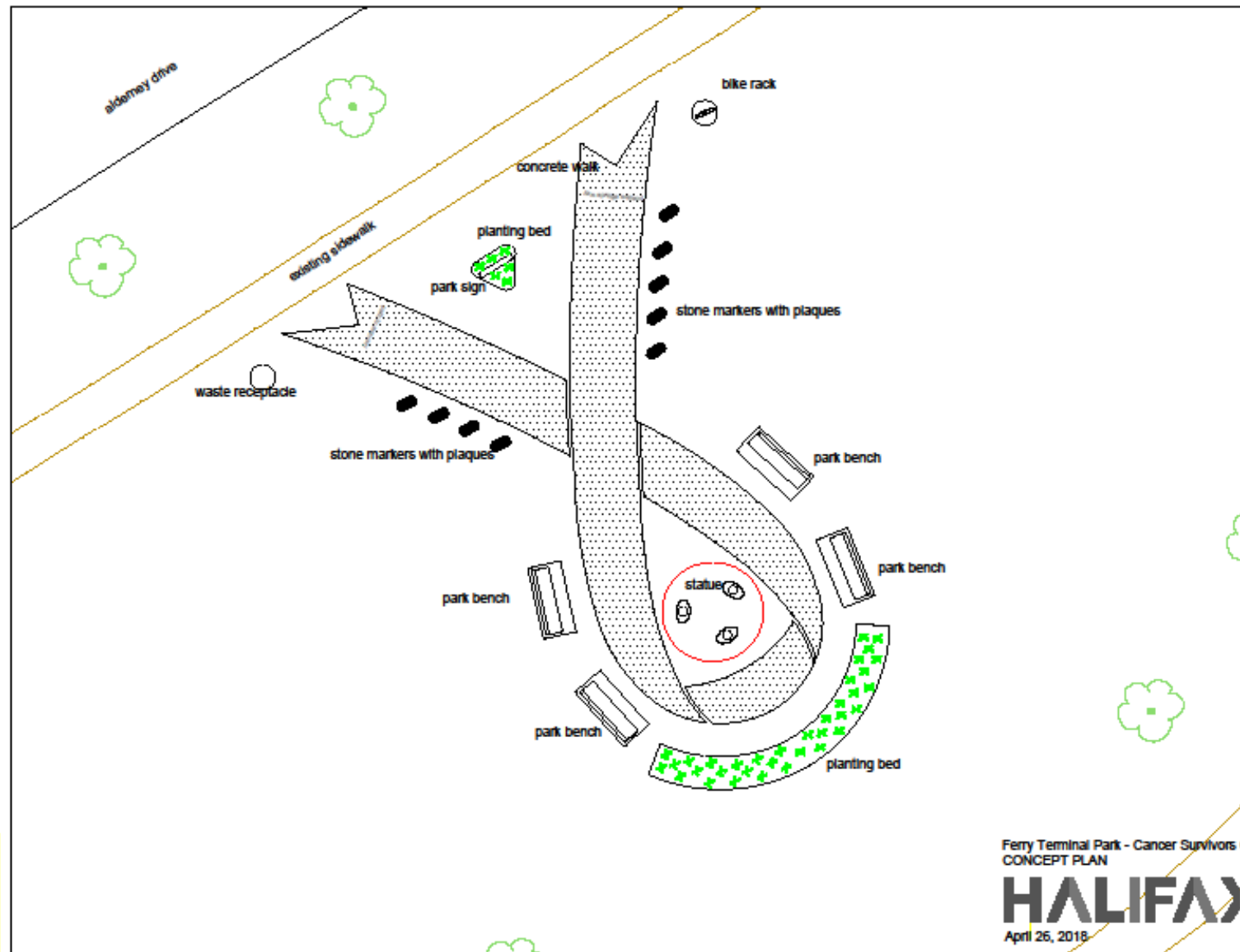
