
Current Public Transportation (Route 207)

- MusGo Rider Cooperative
 - Provides door to door transportation from East Ship Harbour to Lawrencetown/East Preston
- Halifax Transit Route 401
 - Provides service on Route 207 as far as Seaforth, where it backtracks its original route to Portland Hills
 - Limited operating hours
 - Proposed termination September 2020


