Hello Ms Nicolls,

I have emailed in the past and have always received clear and concise answers from you with regard to my questions. I am hoping you would be able to indulge me once again.

With the Federal Election in a matter of weeks one of the things Mr Trudeau and his Party have promised was to allow municipalities the power to ban handguns to fight crime. As a gun owner who has passed the tests, have had extensive military and civilian training with firearms and as a I restricted firearms owner I get run through the CPIC data base in what is called a Continous Eligibility Check I am concerned to how this may playout. Ms Nicolls there is no doubt that the HRM has a crime problem but that problem is not caused by legal gun owners such as myself. I think you would find most of the firearms used in those crimes were brought in from outside the country. If a handgun ban was implemented in HRM, it would not only affect myself but 100s if not 1000s of other residents. You would either force us to move, force us to get rid of some very valuable property that are secured properly within the limits and in most cases exceeding the RCMP rules for firearms storage. If we were forced to store them at our ranges you would be forcing those ranges to drastically upgrade storage space that they may not have. My membership is with the Musquodobolt Valley Rifle and Revolver Club which is some distance from the city as you know. Storing firearms in an isolated area like that would definitely entice the criminal element. to "go shopping". There are several local business that relay on the sale of handguns, ammunition and accessories that help employ citizens of the HRM. A ban would force a lot of these people out of business or force them to cut down the number of employees that they employ. I work periodically at Nova Tactical in Burnside and see local RCMP, HRPD as well as members from the naval Maritime Tactical Operations Group come in and train on their respective firearms not to mention the scores of people who come through the doors on a daily basis to shoot firearms for the first time.

As Mayor Savage is a former Liberal MP, myself as well as many others are wondering his stance and are watching with some degree of fear. We took some measure of comfort when the HRPD stated they would not support a handgun ban but since they work for the Mayor and the city, they will take their orders from him.

In closing I urge you not to support such drastic measures that would effect only those that obey the law.
