NOTICE OF SECOND READING BY-LAW P-1201, RESPECTING ON-STREET PARKING PERMITS AND BY-LAW P-507, RESPECTING PARKING METERS FOR THE REGULATION OF PARKING OF VEHICLES LEFT STANDING IN THE HALIFAX REGIONAL MUNICIPALITY

TAKE NOTICE that the Council of the Halifax Regional Municipality will consider the adoption of By-law P-1201 and By-law P-507 at a meeting of Regional Council to be held on **Tuesday, November 26, 2019**, in the Halifax Council Chamber, 1841 Argyle Street, Halifax.

By-law P-1201 will amend By-law P-1200, Respecting On-Street Parking Permits. The purpose of the amendment is to make necessary changes in anticipation of parking technology including expanding permit zones, changes to the permit application process permit parking fees.

By-law P-507 will amend By-law P-500, Respecting Parking Meters for the Regulation of Parking of Vehicles Left Standing in the Halifax Regional Municipality. The purpose of the amendment is to make necessary changes in anticipation of parking technology transitioning to paid parking zones, and changes to on street parking and permit parking fees.

The Council will receive written submissions from interested persons concerning the above by-laws at the **November 26, 2019** session of Council.
