## SACKVILLE RIVERS ASSOCIATION – GRATEFUL FOR ELECTROFISHER



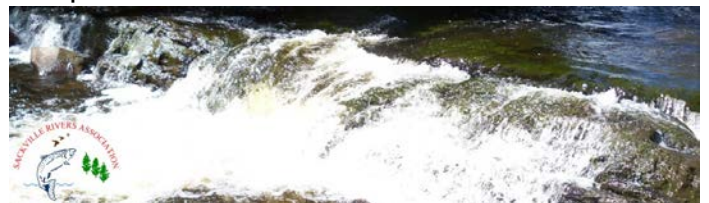

- counting fish species in the river

- species inventory and protection.

SRA also lends the equipment to other volunteer river groups. The Electrofisher is a revenue source as it is rented to various Consultant companies who wish to borrow the unit.

### HALIFAX TRANSIT CHANGES NOW IN EFFECT FOR BEAVER BANK

As of November 25<sup>th</sup>, major transformational changes came into effect regarding transit service in Beaver Bank. To say I was disappointed for residents of North Beaver Bank would be an understatement.

I want you to understand how we got to this point and what work has been done to help residents in North Beaver Bank who rely on transit:

- In 2016, about a month following my election as Councillor for District 14, the [Moving Forward Together Plan](#) (MFTP) was passed by Regional Council; at which time the routes had already been determined and public consultation completed.
- I made it very clear that I was not happy with the cancellation of the North Beaver Bank route and questioned the passenger numbers used to justify the cancellation. I felt the numbers were too old and did not accurately reflect those currently using transit. **I asked for a new count to be done in early 2017**; however, the numbers were still below the threshold needed to maintain the service.
- In August 2018, **I asked staff for a report on the possibility of keeping bus service during morning and afternoon peak hours**. That suggestion was voted down by the Transportation Standing Committee and Regional Council in [January 2019](#).
- The current changes were not supposed to happen for another year; however, upgrades to Halifax Transit software meant the changes could be fast-tracked.

- Since January 2019, **I have met with concerned community members to discuss alternatives as well as three of the Community Transit service providers** in the province: MusGo Rider, East Hants Rider and West Hants Transit. The Community Transit service providers all require permission from the provincial Nova Scotia Utility and Review Board (NSUARB) to expand their service area. None were interested in expansion at this time.
- **I also studied a [pilot project](#) conducted in Cape Breton** that used local taxi services to provide transit options in rural communities. While great in theory, it would require grants from the municipality to taxi drivers. Under the Halifax Charter, we are not permitted to do that and, amendments to the Halifax Charter can only be made by the provincial government.
- The Ivy Meadows facility does have a bus for residents but was not interested in expanding the service.
- Recently, the province announced a Rural Ride Share Field Test that uses ride-sharing to help with public transportation in rural areas. **I have written to The Honourable Minister Derek Mombourquette** (see letter at end of this article) **asking that North Beaver Bank be considered for the pilot project**

If I had the ability to maintain the service, I would have. I am committed to continue working for North Beaver Bank service. It may mean going back to our roots and the days of the Beaver Bank Bullet - it will take a community effort and I will work with any group in support of such an initiative.

I have also suggested residents look into [HfxRidematch.ca](http://HfxRidematch.ca), a carpooling register that could help residents looking for rides.

For the majority of Beaver Bank, the recent changes introduced by Halifax Transit bring a level of Transit Service unheard of in our history. It is my hope that Express Bus Service and a more consistent/expanded schedule will entice residents to take the bus. I know I will be taking the bus more often because of it.

As Councillor for a district with a rural component, I read with great interest your announcement of the Rural Ride Share Field Tests. The goal to deploy permanent on-demand mobility technology services will go a long way to helping provide our rural residents with transportation options. Public transportation in rural areas of Halifax Regional Municipality has proven to be a challenge for us.

As you move forward, I ask that you consider the community of North Beaver Bank as one of the locations for your pilot project. The area lies between the Beaver Bank Kinsac Community Centre on Highway 354 and the Hants County line. The community has recently lost their Halifax Transit service and has a heightened interest in transportation options. It is a community that would be a good fit for this project.

Congratulations on this important initiative for rural residents. I wish you the best of luck.

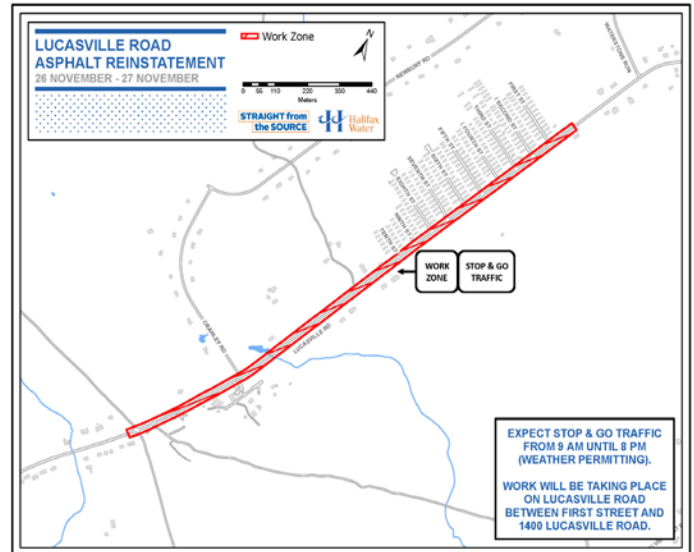

## LUCASVILLE ROAD – WATERMAIN TWINNING PROJECT UPDATE



On November 26<sup>th</sup> and 27<sup>th</sup> Atlantic Road Construction and Paving (ARCP), on behalf of Halifax Water, did asphalt reinstatement work on Lucasville Road. This work is another step closer to finalizing the project.

I have received numerous questions on whether a paved bike lane will be part of this project. The answer is no. The option of paved shoulders/bike lanes had been considered, however; consultation with the community prior to the commencement of the Halifax Water project determined that a separate path/trail which would be safer than a paved shoulder, was the preferred option.

### EGG-LAYING FOWL SURVEY



An [online survey](#) is available for you to share your thoughts about having egg-laying fowl in your neighbourhood. You can also comment on the types of fowl you

would consider having/keeping in your neighbourhood.

Your comments will assist Regional Council in deciding on whether to allow households to keep and raise egg-laying fowl in residential areas for personal use only. The types of bird, and the number of birds that would be permitted, may differ between rural, suburban and urban areas. Males, such as roosters, would be considered only where noise is unlikely to be an issue.

The [original Council motion and staff report](#) focused on chickens, but at the [July 30, 2019 session](#), Regional Council decided to expand the scope to include other birds kept for the purpose of egg laying (ducks, geese, guinea fowl, quail and or turkeys).

This is not about farming. It is about allowing people living on residentially zoned lands, whether in the city, suburbs or rural areas, to keep a small number of domesticated birds to provide eggs for the household's own use.

Raising birds for meat, selling birds or eggs would not be permitted.

Municipal Community Food Security initiatives and the direction of the Halifax Green Network plan support policy work on allowing egg-laying fowl in residential areas. Any policy changes regarding allowing egg-laying fowl in residential areas must be closely coordinated with the

recently approved Centre Plan and the By-law simplification program.
