SANITARY ENGINEER'S SUPPLEMENTARY RECOMMENDATIONS

Read report from the Commissioner of Health as follows:-

Re: Sanitary Engineer's Supplementary Recommendations.

The following permit applications have been received and are recommended for approval by the Committee on Public Health and Welfare subject to compliance with the regulations:

At a recent meeting of the Works Committee the application of Mr. Howe for a dwelling at Africville was considered and the question of providing this district with water was brought up. I understand that the City Solicitor contacted the Department of Municipal Affairs, who in turn state that the

Inspection of the above premises shows that a very unsanitary condition exists and the premises are unfit for habitation. It is therefore recommended that the Committee deem that this tenement house used as a dwelling house be so unfit for that purpose that the public health is endangered thereby and order that it shall be vacated by not later than August 20, 1949 and in case of disobedience thereto or of a re-occupation of the dwelling house without a permit, the Committee direct a warrant to the Sheriff or Constable or Sanitary Inspector to enforce compliance with the terms of such order.
