- 13. They submit letter Chairman House & Grounds Committee, Tower Road School, regarding muddy spot in their school yard and recommend that the matter be referred to Mr. Freeman for his attention and necessary action.
- 14. They submit report of the Buildings Superintendent of work carried on during the month and recommend that the work of pointing the schools as mentioned in annual estimates should be done, the Secretary was instructed to see the Commissioner of Finance in regard to amount of Capital funds already on hand to see if any of this work could be done from those funds.
- 15. They submit letters Canadian Paraplegic Association and Canadian Foundation for Poliomyelitis together with Brief re classes for these handicapped people, the possibility of installing elevator at new Senior High School etc. and recommend that same be referred to the Supervisor as this all ties in with a recommendation to be made to the Committee on Teachers.

AFRICVILLE SCHOOL:

Letter from Commissioner Cowan re conditions at Africville School was read togetherwith report of the Supervisor as to cost of transporting the children into the City Schools, and also report of the Superintendent of Buildings as to cost of making the improvements suggested by Comm'r. Cowan's letter, approximate cost of repairs, changes etc. \$13,500. Estimated cost of transporting children, \$5,000.00 per year.

It was the opinion of most of the Commissioners that the matter should be discussed with the people interested and their wishes ascertained in connection with the matter as it was thought they would not want to be moved into the City.

Moved by Comm'r. Butler, seconded by Comm'r. Vaughan that the Chairman of the Board, the Chairman of the Committee on School Sites and Buildings, Comm'r. Cowan and the Supervisor take the matter up with the Rev. Mr. Oliver and others who might be interested, and report at the next meeting of the Board.
