## ORIGIN

## LEGISLATIVE AUTHORITY

#### Halifax Regional Municipality Charter

- Section 7A The purposes of the Municipality are to (b) provide services, facilities and other things that, in the opinion of the Council, are necessary or desirable for all or part of the Municipality
- Section 23 The Council may establish, by policy, citizen advisory committees which shall advise the Council, as directed by the Council

#### BACKGROUND

The Western Common Wilderness Master Plan (Master Plan) was adopted by Regional Council on June 15, 2010. On May 31, 2016, Regional Council established the Western Common Advisory Committee (WCAC) by Administrative Order 2016-001-GOV with the following responsibilities:

Duties of the Committee

6. The Committee shall monitor the phased development of the Western Wilderness Common and advise Council, through the Halifax and West Community Council, on the community perspective of the implementation of the Master Plan as follows:

- (a) the Committee shall advise Council on detailed planning and development of the Park; and
- (b) the Committee shall advise Council on environmental sustainability in the Park, including:
  - (i) public access and wilderness recreation programing;
  - (ii) impact of land uses, within and adjacent to the Western Common, on the Park;
  - (iii) ecological diversity and connectivity;
  - (iv) cultural landscapes; and
  - (v) park operational matters

At the September 27, 2017 WCAC meeting, a motion was passed requesting staff to produce an annual report on the progress in implementing the Master Plan. The WCAC suggested the report outline: budget allocation; progress of trail construction; construction issues; and, whether there are issues related to operations, accessibility or the environment. Regional Council subsequently passed a motion requesting the annual report from staff.

#### **DISCUSSION**

The WCAC met four times in 2019 with a focus on trail construction, standards outlined in the Master Plan, and potential water crossings. In support of this work, consultant reports were prepared on a bridge crossing over Nichols Run, a watercourse between Nichols Lake and MacDonald Lake, and future trail construction (Attachment A).

#### **Budget Allocation**

Highlights of the capital budget for trail and bridge construction in the Western Wilderness Common include the following:

- \$54,555 (excluding tax) was awarded to WSP Consulting for the Nichols Run bridge crossing design, with funding provided from an already approved budget of approximately \$89,000;
- \$5,555 (excluding tax) was awarded to Cobequid Trail Consulting for a report on future trail work, with funding provided from the same already approved budget of approximately \$89,000;
- no additional funds for the Western Wilderness Common are proposed through the Parks and Recreation budget in 2020/21;

- there may be a possible allocation of funds for the Western Wilderness Common in 2021/22 associated with the District 11 Community Integration Fund, which is to be determined through community consultation<sup>1</sup>; and
- in 2021/22, new funds are anticipated to be contained within a general account for recreation trails throughout the municipality from which future allocations for work in the Western Wilderness Common may be possible.

#### Trail Progress

Approximately 1,000 meters of trail has been constructed to date, which includes clearing, grubbing and gravels, but not to a finished state. This is to allow for continued access by vehicles and machinery for future trail construction. The trail work originates at the Prospect Road Community Centre and branches into two sections: one to a waterfall at the eastern edge of Nichols Lake and another to Nichols Run.

#### **Construction Issues**

#### Nichols Run Crossing

The WSP Consulting bridge crossing design work for Nichols Run began with field work in August 2019 and to date, has included:

- survey field work;
- survey drawings;
- geotechnical field work;
- hydraulic analysis field work; and
- preliminary bridge designs.

A draft report is anticipated to be reviewed by the WCAC in early 2020. This is a substantial crossing that will require a significant capital investment in future capital budgets, once the design is finalized.

#### Future Trail Development

Cobequid Trail Consulting is identifying the best trail route from the north side of Nichols Run to the Old Coach Road section, pursuant to the Master Plan. Several challenges associated with numerous identified watercourse crossings have already been identified and a report is to be presented to the WCAC in early 2020.

#### **Operations, Accessibility and the Environment**

On June 5, 2018, Regional Council directed staff to develop a terms of reference for background studies for future secondary planning for a proposed expansion of the Ragged Lake Industrial Park. This industrial development is envisioned within the Master Plan, but matters such as its size and interface with a revised Western Wilderness Common are to be determined. Staff will be providing the WCAC with information on this planning project including a year long study of natural systems in the area, which is to begin in February 2020.

#### FINANCIAL IMPLICATIONS

There are no financial implications related to this report.

<sup>&</sup>lt;sup>1</sup> The Community Integration Fund represents funding for community initiatives because of new or expanded waste resource facilities in the area. The proposed capital budget identifies \$25,000 in 2020/21 for community consultation and \$300,000 in 2021/22 that is to be allocated between the Western Wilderness Common and Prospect Road Community Centre projects.
