MESSAGE FROM DIABETES CANADA



it is even more apparent that we need to work together to protect residents while we do our best to live and work in new and challenging ways.

Diabetes Canada donation bins are overflowing, and some are becoming a dumping ground for well-meaning citizens who want to support our work. Due to the covid-19 pandemic and crucial physical distancing orders by governments that non-essential services be stopped, the pick-up of all textile donations by Diabetes Canada from homes and donation bins across Canada stopped on March 23rd.

The current donations at the donation bins and, in some unfortunate instances, the *dumping of garbage* at donation bins is posing a serious health and safety issue.

Diabetes Canada has been urging the public to hold off on their bin donations until business resumes.

Diabetes Canada relies on generous charitable clothing donations as a crucial source of revenue to support the 11 million Canadians living with diabetes or prediabetes. Efforts include innovative diabetes research, supporting children and youth living with type 1 diabetes, and

developing evidence-based policy recommendations to improve the lives of those living with the disease. Additionally, thanks to the donation bin business, more than 100 million pounds of textiles are diverted from landfill annually.

In addition, watch for posted street cleaning signs and areas that have multiple signage.

BE ATTENTIVE WHERE YOU PARK!



Yes, fees at parking meters have been waived during the COVID-19 pandemic, however; that does not mean you can <u>park</u> where ever you please. The Motor Vehicle Act must still be respected and enforced.

Only parking meter fees have been waived, all other regulations and laws are still in effect and are being enforced.

Downtown signs can sometimes be tricky, so when parking, don't risk it: read the sign carefully. Some roads in the downtown core have rush-hour, no-stopping zones. If your vehicle is parked at one of these locations during the posted rush hour times, it will be towed and impounded.

CAN'T PAY YOUR RENT DUE TO COVID-19?

No Evictions for Three Months

The Premier has stated "No tenant can be evicted because their income has been impacted by COVID-19 (effective for next 3 months)."

- People are not required to be sick with COVID-19.
- Landlords may not serve a tenant with a Notice to Quit (eviction notice) until 15 days after rent was due, and Landlords should not serve anyone who has had their income impacted by COVID-19

NEW POET LAUREATE FOR HRM

Sue Goyette is the Municipality's official Poet Laureate. In assuming the role, Sue replaces outgoing Laureate, Dr. Afua Cooper who has held the position admirably since April 2018. As the Municipality's eighth Poet Laureate, Sue will serve a three-year term, acting as an ambassador for poetry, literacy, literature and the arts.

A prominent poet and author, Sue has published six books of poems and a novel. Her forthcoming collection is Anthesis (Gaspereau Press, 2020). Sue has been nominated for several awards including the 2014 Griffin Poetry Prize and the Governor General's Award and has won the CBC Literary Prize for Poetry, the Earle Birney, the Bliss Carman, the Pat Lowther, the J.M. Abraham Poetry Award, the Relit Award, and the 2015 Lieutenant Governor of Nova Scotia Masterworks Arts Award for her collection, Ocean. She edited the 2014 Best of Canadian Poetry Anthology and the 2017 Griffin Poetry Prize Anthology. Sue teaches in the Creative Writing Program at Dalhousie University.

The Municipal Poet Laureate is selected through an open call for submissions administered by the Culture and Events division. Sue was the consensus recommendation of a peer selection committee made up of cultural sector stakeholders, institutional partners and municipal representatives.

The following are highlights of actions taken to assist you during the COVID-19 pandemic:

Online Permits and Applications

- An <u>online form</u> has been created for all permit and sub-division application intakes.
- Applications for Rezoning, Municipal Plan Amendments, Development Agreements, or Downtown Halifax Site Plan Approvals can be submitted via email to Carl Purvis – Planning

 Revised drawings and/or any amended application information for current files can also be submitted via email, directly to the planner assigned to your file.

Halifax Transit

Halifax Transit is in contact with Public Health and continues to take direction regarding all necessary steps required to safeguard the health of employees and the public.

- Buses and ferries will continue to operate on a <u>reduced schedule</u>.
- The 5-person social gathering limit and two metre social distancing limit does not apply to Halifax Transit as stated in the provincial order.
- Halifax Transit has taken steps to reduce the spread of COVID-19 including an increased frequency of wipe-downs of high-touch surfaces, making the first seat unavailable to riders on buses (this does not impact accessible seating), limiting passengers on buses to seated passengers only, and limiting the number of ferry passengers to 25 per trip.
- Riders must continue to board and exit through the rear doors only and are asked to only use transit services if necessary.
- Riders should continue to social distance as much as possible and

respect the signage indicating what seats are not to be used.

 Riders should not use transit if they are feeling unwell.

WHAT ARE THE PERMITTED USES FOR MY PROPERTY?

Ever wonder what the zoning is for your property and what the permitted uses are under the Land Use By-law? Well, the answers are at your fingertips as you can look it up on the municipal website under EXPLORE HRM's interactive maps.

For example, let's use 1841 Argyle Street – the civic address for city hall. We find that the zoning is ICO – Institutional, Cultural, Open Space. Click on the blue lettering ICO and it will take you to the Land Use By-Law that outlines the permitted uses in an ICO zone.



The link to the Land Use By-Law then shows that the permitted uses in an ICO zone – see below.

Institutional, Cultural & Open Space Zone (ICO)



Permitted Land Uses

(16) The following uses shall be permitted in the ICO Zone:

Institutional uses; Cultural uses; Open Space uses;

Eating establishments or retail uses accessory to permitted uses; and Uses accessory to the foregoing.

(17) Where eating establishments or retail uses accessory to permitted uses are permitted they shall have no separate entrance from the exterior of the building.

LOCAL POETRY - CALL FOR SUBMISSIONS



The Writers' Federation of Nova Scotia (WFNS) in partnership with the Halifax Regional Municipality and Halifax Public Libraries, is bringing back another year of Poetry in Motion to the city of Halifax and beyond.

Poetry in Motion is a public poetry art project that features short poems on transit ads in buses; on digital signs at libraries, ferry terminals, and recreation centres; and on social media posts.
