#### **REVISED 2020-21 BUDGET APPROVED**

Given the impacts of COVID-19 on the municipality, all HRM business units presented revised budget plans than those presented earlier in the year. Regional Council has approved \$787-Million in total municipal expenditures, provincial mandatory contributions of \$168-Million and a capital plan of \$150-Million as part of the 2020/21 municipal budget. HRM Council approved the residential tax rate to remain unchanged, acknowledging that the average residential tax bill will increase due to growth in property assessment values. The average single-family home tax bill will increase by \$27, or 1.4% overall. The average commercial tax bills will also increase by 1.4%. #### **HSW ALTERNATIVES FOR DISPOSAL**

While the HRM Household Special Waste (HSW) program has been suspended for this summer, it is important to note that there are free alternate options available to residents to dispose of common HSW materials.

Paint and empty paint cans can be dropped off at any Enviro Depot location in the Province. Residents are asked to call ahead to confirm changes to hours of operation and additional materials accepted. ### SWIMMING POOLS & FENCING LAWS

Residents with either an above-ground or in-ground swimming pool are required to obtain a permit. To obtain these permits, details of pool location, fencing and security must be identified as specified in HRM By-law S-700: <u>www.halifax.ca/</u> <u>sites/default/files/documents/city-hall/legislation-by-laws/</u> <u>By-lawS-700.pdf</u>

This applies to all swimming pools with a diameter of 11 feet or more and a depth of 2 feet or more. And they should be completely enclosed with a 5-foot high fence. For more information and details, please go to:

# hfxALERT EMERGENCY NOTIFICATION

HRM has a mass notification system for keeping residents informed about emergencies and operations updates. hfxALERT will send urgent and non-urgent notifications from Halifax Regional Police, Halifax Fire & Emergency's Emergency Management Division, as well as municipal winter parking ban notices. Residents need to sign-up for notifications via the HRM web-site. www.halifax.ca/firepolice/fire/emergency-management/hfxalert HRM's current service provider, Everbridge, offers users a mobile app. www. everbridge.com/products/mobile-apps/download/ You are not required to download the app to receive hfxALERT notifications. As with all third-party apps it is the user's responsibility to review the app's Privacy Notice and Terms of Use. With the Everbridge App, notifications will be sent to you based on your immediate location. For this to work, your location services must be turned on on your mobile devices. However, you will not necessarily receive any courtesy notification or urgent public safety locations outside of your immediate location. For example, if you are away from your home, and have not signed up online, you may not receive a notification about an incident near your home. You must sign up with hfxALERT to receive certain notifications. https:// member.everbridge.net/453003085617760/login This will ensure the municipality can reach you to share important information guickly based on set locations, such as your home or workplace.
