**SUBJECT:** Addition of Sites to Administrative Order 53

---

## **ORIGIN**

- At the March 26, 2019 Regional Council meeting:  
MOVED by Councillor Austin, seconded by Deputy Mayor Mancini  
That Regional Council request a staff report on amending Administrative Order 53 Respecting Alcohol in Municipally Owned and Operated Facilities and at Municipal Events to allow for special occasion licenses at the Park Avenue Community Oven on the Dartmouth Common.
- Requests received by staff to add additional locations under Administrative Order 53.

## **LEGISLATIVE AUTHORITY**

Administrative Order 53: Respecting Alcohol in Municipally Owned and Operated Facilities and at Municipal Events (*Municipal Alcohol Policy*)

Halifax Regional Municipality, s. 59(3)

(3) In addition to matters specified in this Act or another Act of the Legislature, the Council may adopt policies on any matter that the Council considers conducive to the effective management of the Municipality.

Halifax Regional Municipality Charter, s. 66(2) and (4)

(2) The Dartmouth Common is held by the Municipality in trust for the inhabitants of the Municipality.

(4) The Municipality may, on the Dartmouth Common... regulate activities on the Dartmouth Common.

## **RECOMMENDATION**

It is recommended that Halifax Regional Council adopt the amendments to Schedule A of Administrative Order 53 (the *Municipal Alcohol Policy*), as set out in Attachment 1 of this report, to add:

1. the lower eastern portion of Leighton Dillman Park adjacent to the Community Oven; Dartmouth Ferry Terminal Park; and the South Common Triangle to the list of Municipally Owned, Operated and Scheduled Public Spaces; and
2. Beaver Bank-Kinsac (#1 & #2), Eddie LeBlanc (#1 & #2), Greenough, Mount Edward Road (#1) and Harold W. Conrad Memorial (#2) diamonds to the list of Municipally Owned, Operated & Scheduled Athletic Fields, Baseball Diamonds, and Facilities Suitable for Adult League Tournament Play

## **BACKGROUND**

On October 8, 2013 Halifax Regional Council passed Administrative Order 53 (the Municipal Alcohol Policy) to manage the use of alcohol in municipal facilities and during events delivered by the municipality. Schedule A of Administrative Order 53 includes a list of facility categories and associated municipal facilities where alcohol is permitted, either permanently or through Special Occasion Licenses.

These categories are:

- Municipally owned and operated community and event facilities;
- Municipally owned, operated and scheduled athletic fields, baseball diamonds, and facilities suitable for adult league tournament play;
- Municipally owned, operated and scheduled public spaces;
- Municipally owned and operated fire halls
- Municipally owned, operated and scheduled public spaces allowed once annually for a designated event; and
- HRM streets where alcohol is permitted when a temporary street closure has been approved.

Since its adoption, the following amendments to Administrative Order 53 have been passed by Council:

- the creation of two new categories in Schedule A: “Municipally owned, operated and scheduled places allowed once annually for a designated event” and “HRM streets where alcohol is permitted when a temporary street closure has been approved”;
- addition of “DeWolf Park - Bedford Days” to the “Municipally owned, operated and scheduled places allowed once annually for a designated event” category in Schedule “A”; and
- addition of “Argyle Street, between Duke Street and Blowers Street” and Grafton Street, between Carmichael Street and Prince Street” to the “HRM streets where alcohol is permitted when a temporary street closure has been approved”; category in Schedule “A”.

## **DISCUSSION**

Administrative Order 53 (AO 53) allows for the use of alcohol in certain municipal facilities and spaces, provided required conditions are met. For licensed private and public events in HRM facilities, required conditions include the licensee obtaining a special occasion license from Service Nova Scotia, complying with all conditions of the license, obtaining appropriate insurance and naming an individual in charge of the licensed premises for the event.

In order to obtain a special occasion license application for an outdoor liquor licensed area, Service Nova Scotia requirements include, but are not limited to:

- a site plan of the area to be licensed including: a) dimensions, b) area enclosures, and c) washroom locations,
- Fire Marshal approval,
- Security details, including: name of hired security company, number of security staff, and number of volunteers, and
- a letter from Halifax Regional Police.

Pursuant to s. 7 of AO 53, where a request is received for the sale or service of alcohol at an HRM owned and operated facility or on streets for which a temporary street closure has been approved by the Engineer that is not otherwise listed in Schedule A, Council may, by resolution, permit the sale or service of alcohol, subject to AO 53 and any other conditions Council may wish to impose.

The request that originated this motion was addressed June 4, 2019 at which time Council passed the following motion:

*THAT, in accordance with section 7 of Administrative Order 53, Halifax Regional Council grant permission for serving alcohol in Leighton Dillman Park at the Park Avenue Community Oven as part of the Dog Days of Summer event organized by B'y Local Dartmouth for one day in June 2019 subject to complying with the terms of Part IV of Administrative Order #53 and all other applicable municipal policies.*

As the group ultimately chose to host the event under a tasting license issued by Nova Scotia Liquor Corporation, which is not permitted under the policy, they proceeded with the event on private property rather than in the park. In anticipation of potential others requests for events at this location, rather than requiring Regional Council to consider this request on a recurring basis, an amendment to add this site to Schedule A of AO 53 would allow the site to be used for events either one time or recurring without requiring Regional Council approval each time. Potential event hosts will still be required to apply for a Special Occasion License and meet the conditions set out by Service Nova Scotia, comply with AO 53 and its related conditions, and follow all other applicable municipal policies. As such it is recommended that the lower eastern portion of Leighton Dillman Park adjacent to the community oven, be added to AO 53, to allow for future licensed events in that space.

In accordance with AO 53, if an event organizer wishes to apply for a Special Occasion License to serve alcohol for any portion of the Dartmouth Common other than near the Park Avenue Community Oven in Leighton Dillman Park as noted in Schedule A, they would be required to obtain Regional Council's permission prior to proceeding.

### **Other Proposed Amendments**

Since AO 53 has been implemented, HRM staff and Councillors have received intermittent requests to serve alcohol at municipally owned and operated sites, some of which noted above have been approved on a one-off basis. HRM staff have also identified additional sites where the service of alcohol could reasonably be permitted. These locations have been identified as a result of newly constructed or renovated sites or housekeeping matters since the original introduction of the AO.

### **Ball Diamonds**

It is recommended that the following diamond sites be added to the AO under the list of Municipally Owned, Operated & Scheduled Athletic Fields, Baseball Diamonds, and Facilities Suitable for Adult League Tournament Play:

- 1) Beaver Bank-Kinsac (#1 & #2) HRM staff have received a request from the Beaver Bank Community Centre through Deputy Mayor Blackburn to serve alcohol at an open space near their site. As the field immediately adjacent to the Community Centre is a school field, it is not recommended to add this site. Rather, the ball diamonds approximately 500m from the Community Centre are recommended.

- 2) Eddie LeBlanc (#1 &#2), these diamonds were not added when the original AO was introduced but have since been renovated and are now regularly used for tournament play.
- 3) Greenough, Mount Edward Road (#1) and Harold W. Conrad Memorial (#2). It is recommended to include these sites due to recent upgrades.

#### Public Spaces

In addition to the council request regarding the addition of the area of Leighton Dillman Park surrounding the Park Avenue Community Oven, HRM staff have received requests from citizens to be able to consume alcohol at events booked at some other public spaces. Those requested locations have been reviewed and are recommended to also be added. Therefore, the following sites are recommended to be added to the list of Municipally Owned, Operated and Scheduled Public Spaces:

- 1) the lower eastern portion of Leighton Dillman Park which includes the Park Avenue Community Oven,
- 2) Dartmouth Ferry Terminal Park
- 3) the South Common Triangle

If Regional Council choose to add these spaces to Schedule A of AO 53, users would be permitted to have alcohol at their events on these sites, provided they have a Special Occasions License from Service Nova Scotia, meet the other requirements of AO 53 and any other municipal requirements for booking and use.

#### **FINANCIAL IMPLICATIONS**

There are no direct financial implications resulting from this report.

#### **RISK CONSIDERATION**

There are no significant risks associated with the recommendations in this report. The risks considered rate Low. Any risks associated with individual events which may be hosted at these sites will be managed through the regular municipal events approval process, booking processes, and subsequent Special Occasion licenses.

#### **COMMUNITY ENGAGEMENT**

There was no community engagement required in the writing of this report. There was significant stakeholder engagement conducted in the development of Administrative Order 53 (Municipal Alcohol Policy).

#### **ENVIRONMENTAL IMPLICATIONS**

There are no environmental implications resulting from the material in this report.

**ALTERNATIVES**

Alternative 1: Council may choose not to amend Schedule A to add the recommended sites. If these venues are not included in Schedule A, any additional requests to serve alcohol during an event in these areas would need to be considered by Regional Council on an individual basis before the host could apply for a Special Occasion License.

Alternative 2: Council may choose to revise the list of recommended sites to be added to AO 53. Depending on the changes, a subsequent council report may be required.

**BE IT RESOLVED** as an Administrative Order of the Council of the Halifax Regional Municipality that Administrative Order 53, the Municipal Alcohol Policy is further amended as follows:

1. Schedule A, section MUNICIPALLY OWNED, OPERATED & SCHEDULED ATHLETIC FIELDS, BASEBALL DIAMONDS, AND FACILITIES SUITABLE FOR ADULT LEAGUE TOURNAMENT PLAY, is amended by:
  - a. adding the following bullet immediately after the bullet “Any All-Weather Turf Facilities”:  
  
“Beaver Bank-Kinsac (#1 and #2)”;
  - b. adding the following bullet immediately after the bullet “Eastern Passage Common (Dennis Naugle, Bob Hilchie, Tommy Davies)”:  
  
“Eddie LeBlanc (#1 and #2)”;
  - c. adding the following bullet immediately after the bullet “Graves Oakley #1 & #2”:  
  
“Greenough”;
  - d. adding the following bullet immediately after the bullet “Halifax Common athletic and sports fields”:  
  
“Harold W. Conrad Memorial (#2)”;
  - e. adding the following bullet immediately after the bullet “Mic Mac #'s 1 & 2”:  
  
“Mount Edward Road (#1)”.
  
2. Schedule A, section MUNICIPALLY OWNED, OPERATED AND SCHEDULED PUBLIC SPACES, is amended by:
  - a. adding the following bullet immediately after the words “SPECIAL OCCASION LICENSES ALLOWED”:  
  
“Dartmouth Ferry Terminal Park”;
  - b. adding the following bullet immediately after the bullet “Granville Mall”:

“Lower Eastern Portion of Leighton Dillman Park adjacent to community oven”;  
and

- c. adding the following bullet immediately after the bullet “Sackville Landing”:

“South Common Triangle”.

**HALIFAX REGIONAL MUNICIPALITY  
ADMINISTRATIVE ORDER 53  
RESPECTING ALCOHOL IN MUNICIPALLY OWNED AND  
OPERATED FACILITIES AND AT MUNICIPAL EVENTS**

**BE IT RESOLVED AS AN ADMINISTRATIVE ORDER** of the Council of the Halifax Regional Municipality as follows:

**Short Title**

1. This Administrative Order may be cited as Administrative Order 53, the *Municipal Alcohol Policy*.

**Purpose**

2. The Halifax Regional Municipality is committed to providing a safe, secure, and enjoyable environment for patrons, staff, citizens, and visitors by ensuring responsible practices for the use of alcohol in municipally owned and operated facilities and at municipal events. HRM is further committed to the health, well-being and safety of its citizens through the reduction of children and youth's exposure to alcohol promotion and the encouragement of alcohol consumption in accordance with Nova Scotia's Low Risk Drinking Guidelines, as are in effect on November 13, 2013.

**Interpretation**

3. For the purposes of this Administrative Order, "alcohol" has the same meaning as "liquor" in section 2(k) of the *Liquor Control Act*, R.S.N.S. 1989, c. 260.
4. In this Administrative Order,
  - (a) "Adult" means any person 19 years of age and over;
  - (b) "Festival" means a series of public special events that take place over one or more days at the same site and with a unifying theme. A festival may include a component that is a licensed public special event;
  - (c) "HRM owned and operated facility" means any building, park, sports field, recreational facility or event space owned and operated directly by HRM that is available for use by the public;
  - (d) "Licensee" means a person who holds a Special Occasion or Permanent License;
  - (e) "Licensed Public Special Event" means a Public Special Event that has a class 3 or class 4 Special Occasion License issued pursuant to the *Liquor Control Act* by the Alcohol & Gaming Division of Service Nova Scotia & Municipal Relations;



- (f) “Licensed Private Special Event” means a Private Special Event that has a class 1 or class 2 Special Occasion License issued under the *Liquor Control Act* by the Alcohol & Gaming Division of Service Nova Scotia & Municipal Relations;
- (g) “Permanent License” means any license issued pursuant to the *Liquor Control Act* by the Alcohol & Gaming Division of Service Nova Scotia & Municipal Relations other than a special occasion license;
- (h) “Public Special Event” means an event that is open to the public to participate;
- (i) “Private Special Event” means an event that is open only to invited guests; and
- (j) “Special Occasion License” means a license to serve alcohol issued pursuant to the *Liquor Control Act* by the Alcohol & Gaming Division of Service Nova Scotia & Municipal Relations. It may be a class 1,2,3, or 4 license, as defined in the Liquor Licensing Regulations.

### **Part I – Alcohol licenses permitted in facilities owned by HRM**

#### **Application**

- 5. Repeal
- 5A. This Part applies to:
  - (a) all HRM owned and operated facilities; and
  - (b) all streets for which a temporary street closure has been approved by the Engineer.

#### **Alcohol not permitted**

- 6. Alcohol is not permitted in HRM owned and operated facilities or on streets for which a temporary street closure has been approved by the Engineer, except as listed in Schedule A.
- 7. Where a request is received for the sale or service of alcohol at an HRM owned and operated facility or on streets for which a temporary street closure has been approved by the Engineer not listed in Schedule A, Council may, by resolution, permit the sale or service of alcohol, subject to this Administrative Order and any other conditions Council may wish to impose.

### **Part II – Alcohol Advertising**

#### **Application**

- 8. This Part applies to:
  - (a) all HRM owned and operated facilities;
  - (b) all Metro Transit assets, including buses, ferries, transit shelters, and transit terminals;

- (c) all bus and park benches owned by HRM; and
- (d) all billboards owned and managed by HRM, located on HRM property.

### **Alcohol Advertising**

9. In addition to any other criteria that may be required, all alcohol advertisements submitted for a facility subject to this Part, or for placement on Metro Transit assets, bus and park benches owned by HRM, or billboards owned by HRM, must also:
  - (a) be in accordance with the *Liquor Control Act* and Regulations; and
  - (b) include messages about both the consumption of alcohol and the options for safe transportation in accordance with Nova Scotia's Low Risk Drinking Guidelines.
10. The advertisement or promotion of alcohol products or brands is not permitted in facilities subject to this Part, except:
  - (a) within an area for which a special occasion license or permanent license has been issued; or
  - (b) where it is done pursuant to an agreement under Administrative Order 55, the HRM Sponsorship Administrative Order, or Administrative Order 56, Respecting HRM Sale of Naming Rights Policy.
11. The distribution of items promoting alcohol products or brands is not permitted in facilities subject to this Part, except within an area for which a special occasion license or permanent license has been issued.

### **Part III – Special Events**

#### **Application**

12. This Part applies to public special events, licensed public special events, and festivals, organized by HRM, whether or not they are held on HRM-owned property.

#### **Alcohol sponsorship and promotion**

13. Alcohol is permitted at a licensed public special event organized by HRM, but persons under 19 years of age are not permitted in the licensed area.
14. Alcohol sponsorship of, and the promotion of alcohol at, festivals and public special events is not permitted, except as follows:
  - (a) Alcohol sponsorship of a licensed public special event, including one that is a component of a festival, is permitted in accordance with Administrative Order 55, the HRM Sponsorship Administrative Order, provided that the logo and/or name of the alcohol sponsor is only

included on that part of any promotional material that is directly related to the licensed public special event.

- (b) Alcohol promotion associated with alcohol sponsorship of a licensed public special event, including one that is a component of a festival, is permitted provided:
  - i) It is in accordance with the *Liquor Control Act* and Regulations;
  - ii) It is contained within the area for which the special occasion license has been issued;
  - iii) It does not use any large scale products for advertising purposes that display the name or logo of an alcohol product or brand, including inflatables;
  - iv) It includes messages about both the consumption of alcohol and the options for safe transportation in accordance with Nova Scotia's Low Risk Drinking Guidelines; and
  - v) It does not promote the over-consumption of alcohol.
- (c) Alcohol sponsorship of a free transit program associated with a festival or public event is permitted.

#### **Part IV – Facility Rentals**

##### **Application**

- 15. This Part applies to licensed private special events and licensed public special events at HRM owned and operated facilities or on streets for which a temporary street closure has been approved by the Engineer.
- 16. Where individuals or groups rent an HRM owned and operated facility or use a street for which a temporary street closure has been approved by the Engineer for a licensed private special event or a licensed public special event they are the licensee for the purposes of this Part, and the following shall be included as conditions of the facility rental or use of the street:
  - (a) The licensee shall obtain a special occasion license from the Alcohol & Gaming Division of Service Nova Scotia & Municipal Relations.
    - i) The licensee shall provide proof of the Special Occasion Liquor License to HRM at least five (5) days prior to the Event.
  - (b) It is the responsibility of the licensee to comply with the terms and conditions of the license, as well as the *Liquor Control Act* and the Liquor Licensing Regulations under which the license was issued.

- (c) For licensed private special events, the licensee shall contact HRM Insurance & Risk Management Services, which will determine the appropriate level of insurance coverage required for the private special event. The licensee shall be required to provide proof of Commercial General Liability Insurance evidencing limits as required by HRM Insurance & Risk Management Services, inclusive of Bodily Injury and Property Damage and with liquor liability not excluded. Halifax Regional Municipality shall be named as an “Additional Insured” on the policy. The licensee shall provide a Certificate of Insurance evidencing proof of the above insurance to HRM no later than five (5) days prior to the event.
  - (d) For licensed public special events:
    - i) The Licensee shall provide proof of Commercial General Liability Insurance evidencing limits of not less than Five Million Dollars (\$5,000,000.00), inclusive of Bodily Injury and Property Damage and with liquor liability not excluded. Halifax Regional Municipality shall be named as an “Additional Insured” on the policy. The licensee shall provide a Certificate of Insurance evidencing proof of the above insurance to HRM no later than five (5) days prior to the event.
    - ii) The Licensee shall consult with the Halifax Regional Police to determine the security arrangements required for the event. The final security arrangements shall, at a minimum, comply with the recommendations of the Halifax Regional Police; and
    - iii) The licensee is responsible to ensure that entrances and exits to the area of the facility to which the License applies comply with the terms and conditions of the license, as well as the *Liquor Control Act* and the Liquor Licensing Regulations under which the license was issued.
  - (e) As part of the application process with HRM, the licensee shall provide the name of the individual who they have designated as being in charge of their licensed premises for the purposes of their special occasion license, and it is the responsibility of that person to remain at the Facility until all attendees have left the event.
17. Individuals or groups who fail to comply with these conditions may be refused access to the space they have rented, may lose their deposit, and may be prohibited from future rentals, at the discretion of the Chief Administrative Officer or designate.
18. To encourage alcohol consumption in accordance with Nova Scotia’s Low Risk Drinking Guidelines, HRM recommends, but does not require, the following risk mitigation strategies to licensees as examples of best practice for licensed events:
- (a) No marketing practices that encourage increased consumption;

- (b) Servers and or/those setting policy for the operation or supervision of bar staff should be certified in Serve Right (responsible beverage server training) or similar program;
- (c) No announcement of “last call”;
- (d) The licensee make available low-alcohol and no alcohol beverages;
- (e) No alcohol sales within one hour of the time authorized by their license to stop selling and dispensing liquor;
- (f) To avoid over serving, no service of more than 2 drinks per person at one time;
- (g) At an Event where tickets are provided for complimentary alcoholic beverages, no more than two tickets should be redeemed per person at one time. Distribution of these tickets should be restricted to a maximum number to avoid over consumption of alcohol, and should only be distributed to those over 19 years of age; and
- (h) Promotion of safe transportation options for attendees who consume alcohol, including: designated drivers, public transportation, taxis.

#### **Part V – General**

##### **Implementation**

19. This Administrative Order shall come into effect on the date that it is passed by Regional Council; however, HRM Business Units shall have until June 30, 2014 to bring operating practices into compliance.
20. Existing contracts for advertising, including sponsorship and/or naming agreements, as well as existing leases of space in HRM owned and operated facilities, are exempt from the application of this Administrative Order and shall be brought into compliance upon expiration of their term, including all renewals previously negotiated by HRM.
21. Nothing in the Administrative Order shall be construed to derogate from the requirements of Administrative Order 2014-010-ADM, the *Special Events Administrative Order*.
