SUBJECT: Moosehead – Community Name Correction

ORIGIN

June 18, 2019 motion of Regional Council:

"MOVED by Councillor Hendsbee that Halifax Regional Council request a staff report to consider correction of the community name of Moosehead to Moose Head."

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter (HRM Charter), Part XII, Street and Highways. S.323.

RECOMMENDATION

It is recommended that Halifax Regional Council maintain the current spelling of the community of Moosehead.

BACKGROUND

Since 1897, official place names have been authorized through a national committee known today as the Geographical Names Board of Canada (GNBC). The GNBC creates and promotes the use of geographical naming standards across Canada. Names are recorded in a national authoritative register known as the Canadian Geographical Names Database. Official place names are the ones that appear on government maps¹.

The community of Moosehead is located on the eastern shore of the Halifax Regional Municipality between the communities of Harrigan Cove and Moser River, a map of which is included within Attachment A. The GNBC has recognized the settlement of Moosehead since 1939 and HRM officially ratified the community name and its boundaries at their meeting on October 30, 2007.

Currently both the Halifax Regional Municipality and the GMBC spell the community as one word, Moosehead. There have been no other official spellings of the community recorded.

Over the years both spellings, Moosehead and Moose Head, have been used on official documents and maps and there is interest in the community to have the name changed to the two-word spelling.

DISCUSSION

Although there is no official requirement for the Municipality to spell their community names exactly the same way as the GNBC, the municipality recognizes that geographical naming is the responsibility of the GNBC and every effort is sought to have the spelling of municipal community names match those listed in the Canadian Geographical Names Database.

As per the policy in Admin Order 29, any community at risk of being affected by major changes in their boundaries shall be informed and consulted before, during and after the process. Staff have interpreted this policy to include any proposed changes in the spelling of the community name.

The Province of Nova Scotia accepts renaming applications for any geographic feature on behalf of the GNBC. Civic Addressing staff completed an application to rename the community name of Moosehead to Moose Head and submitted it to the province for review. The following are the steps required to have a geographic name changed. Each step must be completed and approved before the next step can be undertaken:

- 1. Review by the Nova Scotia representative on the Geographical Names Board of Canada (further research and field investigation may be completed).
- 2. Obtain community support (strong support is required minimum of 75% of property owners within the community must be in favour of the proposal).
- 3. Approval of local Municipal Council.
- 4. MLA support.
- 5. Submission of Council minutes and letter of support from the MLA, which are reviewed by the GNBC.

Civic Addressing staff received confirmation from the Province that the initial review was approved as there was evidence that the community name has been spelled both as Moosehead and Moose Head.

The Province and the Municipality agreed to a joint consultation project and on June 19, 2020 forty-nine letters (Attachment A) were sent to all the property owners in Moosehead. The letter invited each property owner to complete an online survey (Attachment A) managed by the Province or to submit their feedback directly to HRM Civic Addressing. Property owners had until August 28, 2020 to provide their feedback. The letter stated that non-response to the letter would be considered support for the name change from

Moosehead to Moose Head.

During the feedback period, 30 (61%) of the 49 property owners responded to the letters. The results of the feedback are as follows:

As the letter indicated that a non-response would be counted as agreeing with the proposed spelling change to Moose Head, the total property owners in favour is 25 (51%). As the Province requires strong community support (at least 75% in favour) the process will not proceed past this step in their process. Therefore, it is recommended that the community name Moosehead be retained.

FINANCIAL IMPLICATIONS

The recommendation of this report does not have any financial implications. Any modification to the spelling of the community name Moosehead would require changes to existing signs. There are two 3'x 6' community signs that would require replacement, at a total cost of approximately \$1,000.00. Current Planning have funds to cover this expense in their approved budget for signage, C420-GL6910.

RISK CONSIDERATION

There are no significant risks associated with the recommendations contained within this report.

COMMUNITY ENGAGEMENT

The community engagement process is consistent with the intent of the HRM Community Engagement Strategy. As per Policy 13 of Admin Order 29 the level of community engagement was notification and consultation with affected property owners. As per the standard consultation process all property owners in the community of Moosehead (49) were consulted by mail.

ENVIRONMENTAL IMPLICATIONS

No environmental implications were identified.

ALTERNATIVES

Regional Council may choose to change the spelling of the community of Moosehead to Moose Head. This alternative is not recommended as the GNBC would not approve this spelling change and the Municipal spelling and the GNBC spelling would no longer be the same.


