#### ORIGIN

It is the practice for Halifax Peninsula Planning Advisory Committee to adopt a schedule of meetings for the upcoming year.

## LEGISLATIVE AUTHORITY

Section 6.1 of the Committee's Terms of Reference – "The Planning Advisory Committee shall meet at least once monthly or as required to conduct the business of the Committee. Additional meetings may be scheduled at the discretion of the Chair in consultation with staff."

#### RECOMMENDATION

It is recommended that Halifax Peninsula Planning Advisory Committee approve the 2021 Meeting Schedule as outlined in the Discussion section of this report.

#### BACKGROUND

Past practice of the Halifax Peninsula Planning Advisory Committee (HPPAC) has been to establish a yearly meeting schedule so that Committee members and the public have sufficient notice of meeting dates. In the event that a meeting is not required and is cancelled, the Clerk's Office ensures the Committee members are notified of the meeting cancellation and public notification of the cancellation is done through HRM's website.

#### DISCUSSION

The HPPAC has traditionally met on the fourth Monday of every month, from 4:30 p.m. to 6:30 p.m. in Halifax Hall, Main Floor City Hall, 1841 Argyle Street, Halifax. Therefore, based on past practice, meeting dates and locations are proposed for 2021 as outlined in Attachment A of this report.
