

- ✓ 5-year term with extension up to 2-years at Municipality's discretion
- √ 8 collection areas
- ✓ Scope of Services:
 - > Residential garbage, organics, and recyclable collection from ~ 140,000 units
 - Provisional services (e.g., weekly organics, peak leaf & yard waste collection)
 - Optional services (e.g., moving to bi-weekly recycling collection HRM wide)
 - Operation of 2 rural refuse depots

RFP 20-085 Collection and Transportation of Source-Separated Solid Waste:

- ✓ Diversity and Inclusion training requirement
- ✓ Safety: side guards, WCB safety certified, monthly reporting
- Carbon Footprint: submission of fuel consumption and mileage data
- ✓ Eastern Passage: Weekly recycling collection
