DARTMOUTH SOUTH - EASTERN PASSAGE

PORTLAND STREET/COLE HARBOUR ROAD IMPROVEMENTS VIRTUAL PUBLIC MEETING

You're invited to attend a virtual public meeting about the Portland Street/Cole Harbour Road Functional Plan on April 7, 2021 from 6:00 until 7:00 p.m. The meeting will begin promptly at 6:00 pm with a presentation, to be followed by a question and answer period with municipal staff and the project consultants.

Halifax's Integrated Mobility Plan calls for the municipality to study existing roads that are important for regional vehicle flow, transit, goods movement and active transportation. The Portland Street/Cole Harbour Road corridor is one of these corridors. A Functional Plan studies how people move along a corridor and how development plays a role in shaping this movement. The study will make recommendations about the future design of the corridor, and how to improve mobility for all users.

During this first meeting and round of public engagement, the project team will present the project background, objectives, and receive feedback from the public about how they currently use Portland Street and Cole Harbour Road and what improvements could be made to the corridor. The feedback received will influence draft designs. The project team will then return for a second round of engagement later this spring and present draft designs for public feedback.

If you are unable to attend the meeting, a video of the presentation including all questions and

answers will be posted on the project website as will an online survey to gain additional feedback. The survey will include questions about how and how often you use Portland Street and Cole Harbour Road, what improvements are most important, and what trade-offs would be the most acceptable. When trying to improve infrastructure for pedestrians, cyclists, transit, and vehicles on the same street, space can be limited, and trade-offs are often necessary.


HALIFAX TREE PROJECT

ACTIVE TRANSPORTATION EDUCATION AND PROMOTION GRANT PROGRAM

Halifax Regional Municipality is pleased to launch the new Active Transportation Education and Promotion Grant Program.

Active Transportation (AT) Education and Promotion Grants are intended to support projects to increase the number of people walking, bicycling and rolling and improving the safety of people using these modes.

Projects may include:

- Safety and skills training programs
- AT promotions and marketing programs
- AT education and engagement
- AT related events
- Etiquette programs
- Transportation Demand Management Programs

There are three types of projects measured in funding and reach:

- Small Community project grant under \$1,000: smaller projects (localized) in one or more communities in HRM
- Large Community project grant of \$1000 -\$5,000: larger project or event (requiring significant logistics efforts) meant to reach a broader audience in communities across HRM;
- Major project grant over \$5,000: large project with significant logistics, partnerships and duration efforts with an intended reach across the municipality

Active Transportation Education and Promotion Grants Terms outline projects' eligibility, evaluation criteria, terms and timelines.

To submit a proposal, please download and save on your computer the Active Transportation Education and Promotion Grant Application. Complete the info requested and sent it along with required supporting documents by email: martinem@halifax.ca.

To be considered, spring-summer proposals and supporting documents required must be received on or before April 9, 2021.

ROAD SAFETY AWARENESS: HEADS UP HALIFAX

Road safety is a shared responsibility for everyone — whether you're walking, cycling, rolling or driving. Through the <u>Strategic Road Safety Framework</u>, the municipality is committed to the Towards Zero approach which is focused on moving closer towards zero fatalities and injuries for people using any mode of transportation by 2023.

To promote Road Safety Awareness, HRM has been undertaking a year-round road safety awareness campaign, <u>Heads Up Halifax</u>. This is done through social media efforts via our <u>website</u>, <u>twitter</u>, <u>Facebook</u>, <u>Instagram</u>, bus shelter ads, bus boards and in community papers. Our ongoing messaging aligns with the monthly road safety themes established by the province. The theme for April is Aggressive Driving.

The focus of our messaging is safe practices on the road for all modes of travel. This includes rules for crosswalks, how to use new municipal infrastructure, and municipal efforts to improve road safety across the region via engineering and traffic calming improvements.

ELECTRIC VEHICLE REBATE PROGRAM NOW OPEN



Nova Scotia's electric vehicle and electric bike rebate program's website is now live. The province is strengthening its commitment to address climate change and grow the economy with its new Electric Vehicle Rebate program. The rebate program is now accepting applications on new and used electric vehicles, plug-in hybrids and electric pedal assist bicycles (e-bikes). The intent of this program is to allow Nova Scotians of varying income levels to take part in the shift to clean transportation. Buyers of new electric vehicles who qualify for the federal government's Zero-Emission Vehicles program are also eligible for the provincial rebate. Quick Facts: The rebate amounts for vehicles are: \$3,000 for new, fully electric vehicles, \$2,000 for used electric vehicles, and new plug-in hybrid electric vehicles, and \$1,000 for used plug-in hybrid electric vehicles.

- A \$500 rebate is available for e-bikes with a retail value of \$1,200 and higher.
- The rebate program is in addition to the \$5,000 federal rebate available for new electric vehicles.
- There are nearly 500 electric vehicles registered in Nova Scotia and more than 100 charging stations across the province.
- The estimated cost of the program is \$9.5 million.

IMPAIRED DRIVING STATISTICS FOR FEBRUARY

Halifax Regional Police charged 23 drivers with impaired related offences during the month of February.

Police received 11 calls throughout the month of February from citizens who suspected impaired drivers. We thank citizens for calling in suspected impaired drivers and encourage citizens to call 911 immediately if you suspect someone is driving impaired.

COMMEMORATIVE NAMING

The Halifax region has almost 6,000 streets, many of which are rich in history and paint a picture of our past. As the municipality continues to grow, new streets, parks, sports fields, and buildings all require names. You can help to keep the tradition of commemorative naming alive and play an important role in building the municipality by submitting names of notable people or groups, historic events, geographic features, or native flora and fauna. REPORT A POTHOLE OR SINKHOLE

Report a pothole or sinkhole on a municipallyowned street or sidewalk <u>here</u>.

Potholes are caused when the asphalt on the surface of a road has deteriorated from the top, but you can still see asphalt underneath.

Sinkholes are caused by erosion from underneath, and when you look into the hole you cannot see any pavement.

If you are reporting a pothole on a 100-series highway, please contact Nova Scotia Transportation and Infrastructure Renewal (NSTIR) at TPWPAFF@novascotia.ca. This includes ramps leading to and from the highway, as well as overpasses above 100-series highways.

SUMMER REGISTRATION FOR RECREATION PROGRAMMING

The Halifax Regional Municipality is advising residents that summer recreation programs have been planned in accordance with public health guidelines.

Currently, Public Health is allowing for multiple cohorts of 15 children in day camps. Full-day and half-day camps are planned to be offered for this summer. If there are changes to COVID-19 guidelines, staff will work with Public Health to assess and adjust programs as needed to balance the safety of all participants and staff. Registration is scheduled to begin at 10 a.m. each of the following days for all ages:
