SUBJECT: **Implementing Natural Surface Back Country Trails within Interior of the Western Common Wilderness Common**

ORIGIN

May 11, 2021 special meeting of Halifax and West Community Council, Item 13.2.1.

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter, Part 1, Clause 25(c):

The powers and duties of a Community Council include recommending to the Council appropriate by-laws, regulations, controls and development standards for the community.

RECOMMENDATION

It is recommended that Halifax Regional Council request a staff report considering proposed amendments to the Western Common Wilderness Common Master Plan to consider the implementation of natural surface backcountry trails within interior areas of the Western Wilderness Common.

BACKGROUND

At their May 11, 2021 special meeting, Halifax and West Community Council received a recommendation report from the Chair of Western Common Advisory Committee to consider requesting a staff report to consider proposed amendments to the Western Common Wilderness Common Master Plan to consider the implementation of natural surface backcountry trails within interior areas of the Western Wilderness Common.

SUBJECT: Implementing Natural Surface Back Country Trails within Interior of the Western Common Wilderness Common

ORIGIN

Motion from the April 28, 2021 Western Common Advisory Committee meeting.

LEGISLATIVE AUTHORITY

Section 5(a) of the Western Common Advisory Committee Terms of Reference:

The Municipality's management of the Western Common will be guided by the following objectives:

- (a) the protection of valuable ecological and cultural assets;*
- (b) the provision of access to sustainable wilderness recreation through improvements and programs;*

RECOMMENDATION

The Western Common Advisory Committee recommends Halifax and West Community Council recommends that Regional Council request a staff report and amendments to the Western Common Wilderness Common Master Plan to consider the implementation of natural surface backcountry trails within interior areas of the Western Wilderness Common.

BACKGROUND

The Western Common Advisory Committee received an update from staff at the April 28, 2021 special meeting that explained to construct trails for all ages and abilities with a sub-5% grade throughout the park would cause significant disruption to the natural setting of the park. This would impact the Municipality's objective to manage the Western Common such to protect the valuable ecological and cultural assets of the Western Common.

DISCUSSION

The Committee discussed the details of the update at the April 28, 2021 special meeting. As explained by staff the impact to the natural setting by implementing sub-5% grade slopes for all ages and abilities would cause significant disruption to the park. This would conflict with the Halifax Regional Municipality's objectives of the park. The Municipality's guiding principles for the park as detailed in the Western Common Wilderness Common Master Plan are to provide "...the protection of valuable ecological and cultural assets;" and "the provision of access to sustainable wilderness recreation through improvements and programs;". In order to maintain as much of the natural setting of the park as possible the Western Common Advisory Committee agreed a staff report to consider implementing natural surface backcountry trails was necessary to minimize impact to the environment.

COMMUNITY ENGAGEMENT

The Western Common Advisory Committee is an advisory committee to the Halifax and West Community Council and is comprised of six members of the public and one appointed member of Halifax and West Common Council. The meetings are open to the public through a public livestream and the agendas and minutes are posted online in advance of the meeting.
