BY-LAW T-1005, RESPECTING THE REGULATION OF TAXIS, ACCESSIBLE TAXIS, LIMOUSINES AND TRANSPORTATION NETWORK COMPANIES

PUBLIC NOTICE is hereby given that By-law T-1005, Respecting the Regulation of Taxis, Accessible Taxis, Limousines and Transportation Network Companies was adopted by Halifax Regional Council on June 8, 2021.

By-law T-1005 amends By-law T-1000, Respecting the Regulation of Taxis, Accessible Taxis, Limousines and Transportation Network Companies. The purpose of the amendment is to change the composition of the License Appeal Committee from individual appeals officers to a three-member adjudicative panel and to enable one member to be appointed Chair of the Committee.
