SUBJECT: Order to Demolish – Case #340499, 954 North Preston Road, North Preston

SUPPLEMENTARY REPORT

ORIGIN

Staff, pursuant to the Halifax Regional Municipality Charter (the "Charter").

LEGISLATIVE AUTHORITY

Sections 355, 356 and 3(q) of the Halifax Regional Municipality Charter, S.N.S., 2008 C.39.

RECOMMENDATION

It is recommended that the Appeals Standing Committee:

Find the property to be dangerous or unsightly as per section 3(q) of the Charter and as per section 356 of the Charter, **orders demolition** of the accessory structure including but not limited to, the removal of all demolition debris, backfilling of any foundation or crawl space, and disconnecting any and all utility connections to the standard set by each respective utility service provider, so as to leave the property in a neat, tidy, environmentally compliant and safe condition within thirty (30) days after the Order is posted in a conspicuous place upon the property or personally served upon the owner. Otherwise, the Municipality will exercise its rights as set forth under Part XV (15) of the Charter.

BACKGROUND:

In addition to this case, there is one additional dangerous or unsightly case at the property for debris violations. The debris violations are being managed by the Compliance Officer under a separate case.

The property is zoned RS (Rural Settlement) and a review of the Hansen database system shows that demolition permit 146092 was issued to the property owner and expired on July 31, 2015 for another structure that was previously on the property, and construction permit 180817 was issued to the property owner to renovate the building and replacing cement blocks.

This case is a result of a service request received on May 2, 2019. The complainant noted debris at the property.

The Compliance Officer is bringing this case forward to the committee to request a Demolition Order for the accessory structure known as the barn (Case # 340499) located at 954 North Preston Road, North Preston.

CHRONOLOGY OF CASE ACTIVITES:

- 08-May-2019 The Compliance Officer conducted a site inspection at 954 North Preston Road, North Preston, hereinafter referred to as "the Property" (attached as Appendix B). The Compliance Officer noted a deteriorated accessory structure that appeared to be used as a barn.
- 19-Dec-2019 The Compliance Officer conducted a site inspection and noted a cinder block structure with failing roof and walls and large holes in the cement cinder blocks. In addition, the Compliance Officer noted debris violations.

The property owner was onsite during the site inspection. The property owner advised the Compliance Officer that they were aware the debris needed to be removed and that the bulk of the debris resulted from the collapsed barn. The property owner further advised the Compliance Officer that they wanted to keep the current accessory structure to house chickens.

9-Jan-2020 The Building Official submitted a structural integrity report for the structure (attached as Appendix C).

The overall comments regarding the structure are: "Observations of this structure were made form the exterior as the building was deemed unsafe to enter and to not upset the owner any more than necessary. The building is in an advanced state of decay and there is little, or nothing left to renovate as lack of maintenance has allowed climatic elements to penetrate the buildings envelope."

- 18-Jan-2020 The Compliance Officer tried to contact the property owner by telephone but was unable to leave a message as the voice mail was full.
- 28-Jan-2020 The Compliance Officer posted the Notice to Appear (attached as Appendix D) at the property.
- 29-Jan-2020 The Compliance Officer spoke with the property owner to advise that the Notice to Appear had been posted and explained the process for the Appeals Standing Committee. The Compliance Officer also advised that they would be on site next week for the debris violations and could speak directly with the property owner if they had further questions.

13-Feb-2020	The case was heard at the Appeals Standing Committee and was deferred to May 31, 2020 to allow the property owner time to obtain the appropriate permit to repair the building.
14-Feb-2020	The Clerk's Office sent a letter (attached as Appendix E) to the property owner explaining the outcome of the Appeals Standing Committed and noted the case would return to Appeals Standing Committee on June 11, 2020 if the permit had not been obtained.
07-May-2020	Site inspections held over due to Covid.
09-Jul-2020	The Compliance Officer phoned the property owner to check on progress and did not receive an answer and was not able to leave a message as the mailbox was full.
24-Jul-2020	The Compliance Officer phoned the property owner to check on progress and did not receive an answer and was not able to leave a message as the mailbox was full.
24-Aug-2020	The Compliance Officer phoned the property owner and spoke with their spouse who advised that the property owner was actively working on the building and removing debris.
30-Sep-2020	The Compliance Officer phoned the property owner to check on progress and did not receive an answer and was not able to leave a message as the mailbox was full.
05-Nov-2020	The Compliance Officer conducted a site inspection with the property owner who was on site. The Compliance Officer noted some progress on the building including repointing on the back of the building and also noted that new materials were on site.
10-Dec-2020	The Compliance Officer conducted a site inspection and noted no significant change since the last site inspection.
	The Property Owner phoned the Compliance Officer and advised that weather had prevented their progress. The Compliance Officer advised the property owner they would re-inspect in 30 days.
14-Jan-2021	The Compliance Officer phoned the property owner and left a voice message requesting a return call with an update.
25-Feb-2021	The Compliance Officer conducted a site inspection with the property owner who was onsite. The property owner advised that weather had prevented progress and they would resume the work when the weather warmed up. The Compliance Officer explained that significant progress was required by early spring or the case would be returned to the Appeals Standing Committee.
08-May-2021	Site inspections held over due to Covid.
07-Jun-2021	The Compliance Officer conducted a site inspection and noted no progress and the property remained in violation.
23-Jun-2021	The Compliance Officer posted a Notice to Appear (attached as Appendix F) at the property and noted 2/3 of the structure had been demolished and resulting debris remained on the property. The Compliance Officer hand delivered a copy of the Notice to the property owner's spouse who advised that the property owner was at work but had started the demolition. The Compliance Officer asked the property owner's spouse to have the property owner call the Compliance Officer.

The Compliance Officer left a voice message for the property owner requesting a return call.

24-Jun-2021 The Compliance Officer sent a copy of the Notice to Appear to the property owner through registered mail.

FINANCIAL IMPLICATIONS

There are no financial implications if the owner complies with the Order. If the Municipality is required to complete the work, the costs will form a debt against the property which may be collected in the same manner as taxes pursuant to the Halifax Regional Municipality Charter, S.N.S., 2008, C.39.

ALTERNATIVES

The state of the property suggests no viable alternative to the recommendation by Staff.

RISK CONSIDERATIONS

The risk consideration rates moderate. The building presents an allurement and due to the advanced state of deterioration, the building poses a safety risk to individuals if they were to enter.

ENVIRONMENTAL IMPLICATIONS

No environmental impact identified.

Halifax Regional Municipality Charter ("HRM Charter) Subsection 355, 356 and 3(q)

HRM Charter, subsection 355 (1) (2) as follows:

- 355 (1) The Council may, by policy, delegate some or all of its authority pursuant to this Part, except the authority to order demolition, to the Administrator.
 - (2) The Council may, by policy, delegate its authority pursuant to this Part, or such of its authority as is not delegated to the Administrator, to a community council or to a standing committee, for all or part of the Municipality.

HRM Charter, subsections 356(1)(3), as follows:

- Where a property is dangerous or unsightly, the Council may order the owner to remedy the condition by removal, demolition or repair, specifying in the order what is required to be done.
 - (3) Where it is proposed to order demolition, before the order is made not less than seven days notice must be given to the owner specifying the date, time and place of the meeting at which the order will be considered and that the owner will be given the opportunity to appear and be heard before any order is made.

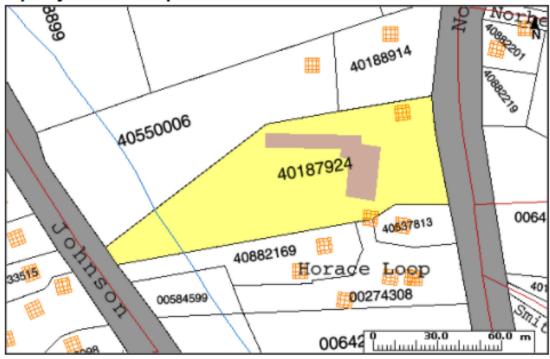
HRM Charter, subsection 3(q) as follows:

- (q) "dangerous or unsightly" means partly demolished, decayed, deteriorated or in a state of disrepair so as to be dangerous, unsightly or unhealthy, and includes property containing
- (i) ashes, junk, cleanings of yards or other rubbish or refuse or a derelict vehicle, vessel, item of equipment or machinery, or bodies of these or parts thereof,
- (ii) an accumulation of wood shavings, paper, sawdust, dry and inflammable grass or weeds or other combustible material,
- (iia) an accumulation or collection of materials or refuse that is stockpiled, hidden or stored away and is dangerous, unsightly, unhealthy or offensive to a person, or
- (iii) any other thing that is dangerous, unsightly, unhealthy
- or offensive to a person, and includes property or a building or structure with or without structural deficiencies
- (iv) that is in a ruinous or dilapidated condition,
- (v) the condition of which seriously depreciates the value of land or buildings in the vicinity,
- (vi) that is in such a state of non-repair as to be no longer suitable for human habitation or business purposes,
- (vii) that is an allurement to children who may play there to their danger,
- (viii) constituting a hazard to the health or safety of the public,
- (ix) that is unsightly in relation to neighbouring properties because the exterior finish of the building or structure or the landscaping is not maintained,
- (x) that is a fire hazard to itself or to surrounding lands or buildings,
- (xi) that has been excavated or had fill placed on it in a manner that results in a hazard, or
- (xii) that is in a poor state of hygiene or cleanliness;
