# ORIGIN

2021/22 capital budget including project CT190006 – Road Safety Improvement and the Traffic Calming Program as presented to Regional Council.

# BACKGROUND

Recent construction tender results are exceeding budget estimates. Industry discussions have indicated that there is considerable cost pressure from the impact of COVID-19 as a result of increases from commodities, supply chain logistics, labour market availability and reduced productivity due to health protocols. Consensus indicates that a 20-30% increase in project costs from pre-COVID budget assumptions can be anticipated.

Over recent weeks these cost increases have been seen in many construction tenders. Despite the increases, staff will continue to tender all projects based upon available funding within respective capital accounts. Inevitably there will be a funding shortfall in some construction accounts for which the tenders may need to be withheld and the accounts topped up through the 2022/23 budget deliberations (as per past practice). Given that road safety, and traffic calming specifically, is a top priority of Regional Council, staff is bringing forward this specific budget shortfall now with the intent of acquiring sufficient funding to tender all traffic calming project commitments in 2021/22.

## DISCUSSION

In May 2021, Regional Council approved the 2021/22 capital budget which included \$3,577,000 for Road Safety Improvements (\$537,000 carry over and \$3,040,000 new funding). Included in the Road Safety Improvement capital project is the Traffic Calming Program. This year's Traffic Calming Program budget totals \$2,215,000 and, in addition to complete streets recapitalization funding, includes traffic calming on an estimated 85 streets which includes 24 school zones. Tender costs for the initial standalone traffic calming projects to date have exceeded budgeted amounts by approximately 25%. Based upon general construction tender experience over the past several weeks it is anticipated that this trend will continue for the remaining traffic calming tenders resulting in a projected shortfall of \$600,000.

To deliver the Traffic Calming project commitments as directed by Regional Council, staff has developed a funding option to offset the projected cost increase for Regional Council's consideration. This option involves reallocation of TPW-related capital and operating budgets as outlined in the Financial Implications section.

### FINANCIAL IMPLICATIONS

To cover the projected \$600,000 shortfall, staff is recommending reallocating an available surplus of \$215,000 in Capital Project CT180003 - Traffic Signal Re-lamping, and reallocating \$385,000 (originally intended for asphalt street patching) from Capital Project CR200005 – Road Ops & Construction – State of Good Repair to Project Account No. CT190006 – Road Safety Improvements.

\$385,000 for asphalt street patching can be accommodated from the Road Ops and Construction Operating budget instead and will be mainly offset by a current forecasted operating budget surplus from Solid Waste. The surplus is primarily due to implementing bi-weekly recyclable collection sooner than anticipated.

The transactions to accommodate the cost increase for CT190006 – Road Safety Improvement can be summarized as follows:

### **RISK CONSIDERATION**

The 2021/22 Traffic Calming Program as directed by Regional Council will not be delivered in full potentially delaying Regional Councils goal 'Toward Zero' to reduce fatal and injury collisions by 20% by 2023.

There is a risk that one or two of the remaining streets to be tendered for traffic calming may not achieve design approval in time to be tendered this year despite the approval of additional funding.

### COMMUNITY ENGAGEMENT

There was no community engagement undertaken for this report.

### ENVIRONMENTAL IMPLICATIONS

No environmental implications were identified.

### ALTERNATIVES

The Audit and Finance Standing Committee could recommend to Regional Council not proceeding with the changes to the capital budgets. This alternative would result in the following 20 streets not receiving speed table traffic calming measures as part of the 2021/22 Traffic Calming Program.
