LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter ("HRM Charter") S.N.S. 2008, c.39

79A (1) Subject to subsections (2) to (4) the Municipality may only spend money for municipal purposes if (a) The expenditure is included in the Municipality's operating budget or capital budget or is otherwise authorized by the Municipality;

Section 79C (1) The Council shall adopt a policy that requires the Municipality to disclose to the public the recipients of grants made by the municipality and the amount of those grants.

It is recommended that Halifax Regional Council approve:

- 1. The award of four (4) Operating Grants as described in the discussion section of the attached staff report (Attachment 1) for a total of \$135,127
- 2. A Capital Grant in the amount of \$6,173 to Halifax Regional Search and Rescue.

The combined total of the grants is \$141,300; funded from Operating Account C801-8004.

ORIGIN

March 31, 2021 – Application deadline for grants under Administrative Order 2014-018-ADM Respecting Grants to Volunteer Search and Rescue Organizations.

LEGISLATIVE AUTHORITY

RECOMMENDATION

It is recommended that the Grants Committee recommend Regional Council approve:

- The award of four (4) Operating Grants as described in the Discussion section of this report for a total of \$135,127
- 2. A Capital Grant in the amount of \$6,173 to Halifax Regional Search and Rescue.

The combined total of the grants is \$141,300; funded from Operating Account C801-8004.

BACKGROUND

Volunteer search and rescue teams provide assistance to all three levels of government in the event of a missing person search, an evacuation, natural or man-made disaster, or evidence search. Although the four (4) organizations formally recognized by HRM are based in predominantly rural locations their search areas cover the entire region and on occasion more than one unit may be called upon to provide volunteer personnel and equipment. Through Administrative Order 2014-018-ADM, HRM provides operating and capital grants to support such organizations.

As of the deadline a total of four (4) applications were received for Operating Grants and one (1) for Capital Grants.

DISCUSSION

Proposed Awards

(i) Operating Grants

Operating Grants are based on an average of three years of core recurring operating expenses deemed eligible under Section 5 of policy and exclude search call-out claims that are reimbursed by the agent of jurisdiction. The value of operating grant is based on the average of the preceding three (3) year actuals as itemized in the applicant's financial reporting, excluding any expenditures deemed ineligible under Section 5 of the policy.

(ii) Project-Specific Grants

In 2021, one (1) application was received for the purchase of equipment. It is considered a capital grant as defined in the Administrative Order and described in Attachment 1 of this report. Applicants shall disclose any application or receipt of funds from any other government, corporate, foundation or personal donation sought or obtained in support of the capital project (Policy, Section 8). Late or incomplete applications may be deemed ineligible. (Policy, Section 9).

In 2021, the value of this capital grant request (\$6,242.47) exceeds the balance remaining in the 2021 program budget and therefore \$6,173.00 is available for this Capital Grant.

Halifax Regional Search and Rescue - Lakeview - Capital Grant/Equipment

The HRSAR team applied for a grant in the amount of \$6,242.47 to fully fund the replacement and extension of the existing forced air furnace to a large classroom space. In a report dated April 9, 2002, the Municipality endorsed a plan to sell the former Lakeview School to HSAR for \$1.00. This was conditional on an MOU with the Lakeview Home Owners Association to retain access to the building for the community. Since this date, HRSAR have extensively renovated and upgraded the building at the expense of its membership. No fees are recovered from the Lakeview group. During an extensive renovation in 2013, former garage space was converted to a training classroom. At this point, funds raised did not permit replacement or extension of the existing heating system. The existing furnace is nearing the ending of its lifespan. Their grant application seeks to both replace and extend the existing forced air furnace to the large classroom space. Quotes provided.

A capital grant in the amount of \$6,173.00 to Halifax Regional Search and Rescue is recommended to fully fund the replacement and extension of an existing forced air furnace.

FINANCIAL IMPLICATIONS

^{**} MVGSAR did not submit 2019 actual expenses, therefore used amount awarded in 2020/21 of \$16,567. The MVGSAR team requested an amount of \$16,300 which was less than the average calculation of 3 years of Operating Expenses equal to \$19,372.

Low. Financial reports are submitted annually to Halifax Regional Fire & Emergency.

COMMUNITY ENGAGEMENT

Capital Grants: Eligibility and Evaluation Criteria

As stated in policy (Administrative Order 2014-018-ADM) a capital grant is:

- a non-recurring financial award towards the purchase of large equipment, the purchase of real
 property, construction, expansion or retrofit of a facility or amenity including in-ground
 infrastructure and telecommunications capacity, instrumentation or specialized safety
 equipment, and major structural repairs to existing amenities (Section 2.g);
- supports the purchase of real property, substantive structural repairs or expansion of an existing facility or infrastructure owned by the non-profit organization, the purchase of instrumentation, specialized or safety equipment in excess of \$500 per item, including ancillary parts or operating system (Section 4.2);

The application form provides directions to potential applicants. The evaluation criteria for capital grants requested under the grants to volunteer search and rescue program is shown below in Table 1.
