

- Ability to stand or walk 2 - 3 ½ hours a day and be exposed to all weather conditions

Crosswalk Guards work up to 3.5 hours per day Monday to Friday, 10 months a year. The hourly rate for this position is \$14.00 (Under Negotiation) accordance with the collective agreement between CUPE Local 4814 and Halifax Regional Municipality.



10 hour certification program

COURSE OVERVIEW

Mental Health First Aid (MHFA) is the help provided to a person who is showing signs of declining mental well-being or crisis. "MHFA – Supporting Youth" is a course designed for members of the public who have frequent contact with young people (ages 12 to 24).



PARTICIPANTS WILL LEARN HOW TO:

- recognize signs that a young person may be experiencing a decline in their mental well-being or a mental health or substance use crisis
- initiate conversations that encourage a young person to talk about a mental health or substance use problem
- discuss professional and other supports that could help with recovery to improved mental well-being
- assist in a mental health or substance use crisis situation
- check in with one's own mental well-being and take action as needed

Participants must be 16 years of age, have access to high speed internet and a webcam and be able to attend all of the online sessions below to receive their certification. Seats are limited, so please consider this before registering.

PHOTO RADAR - FEASIBILITY STUDY



The municipality is now three years into its five-year [Strategic Road Safety Plan](#) that focuses on reducing

transportation-related fatalities and injuries on our roadways. The use of photo enforcement technology has been identified as a tool to help make intersections safer by reducing aggressive driving behaviours such as red light running and speeding. Although this technology is used in many cities across Canada, it is currently not used in HRM but it may be in our future.

HRM is currently looking for a consultant to conduct a study for the photo enforcement program (red light camera and electronic speed detection) within the municipality, to understand if it is a feasible and beneficial option for us.

Regional Council would vote on this matter after the report is complete, and staff would make recommendations to Council based on the report's findings.


Photo enforcement facts:

- Red light cameras and electronic speed detection devices can help reduce the number and severity of collisions on our roadways.
- Has shown to be effective in increasing compliance with traffic signal operations and posted speed limits, reducing the risk of fatal and serious injury collisions.

- It can offer a deterrent beyond that of a reasonable police presence on a roadway.

I look forward to learning the outcome of this report and continuing to work towards safer roadways in HRM.

ALL AGES AND ABILITIES BIKEWAY ROUTES



Halifax is on its way to having nearly 60km of interconnected 'All Ages and Abilities' (AAA) bikeway routes. It's part of HRM's [Integrated Mobility Plan](#) to develop safer and more accessible ways to get around our municipality.

HRM recently awarded Colliers Project Leaders with the contract to help bring this bike network to life. The bikeway network is expected to be completed in 2024. However, parts of it are already underway. Once completed, the network will include [protected bike lanes](#), [multi-use pathways](#) and [local street bikeways](#).



A strong group of regional organizations, called The Sandy Lake-Sackville River Regional Park Coalition, has formed to raise awareness and protect this treasure that stretches between the Sackville River and Hammonds Plains Road – for wildlife and for future generations to enjoy as those have before them.

A stunning beach and pristine lake situated between our fastest growing communities, Bedford and Sackville. Much of the land has been acquired to create a park and only a few gaps remain.

The Sandy Lake-Sackville River Regional Park is currently one thousand acres. It has been recognized for nearly five decades, provincially and municipally and in multiple reports and studies, to be a unique landscape worth

The jury noted the improved re-use of the existing pool and arena spaces, which were united by a new connector/circulation hub. The Zatzman Sportsplex now uses internal daylight and layered views into adjoining spaces to create an enhanced environment for the public.



An Award of Merit in the Small Building Category was awarded to Abbott Brown Architects for the renovation design of the Alderney Pedway in Dartmouth, Nova Scotia. The jury recognized the designer’s effective strategy of “humanizing an indifferent public space with the intervention of scaling elements that create a variety of inviting spaces for people to hang out either alone or in groups.”

HALIFAX REGIONAL MUNICIPALITY’S LAND ACKNOWLEDGEMENT

Land Acknowledgement

The Halifax Regional Municipality is located in Mi’kma’ki, the ancestral and traditional lands of the Mi’kmaq people. The municipality acknowledges the Peace and Friendship Treaties signed in this Territory and recognizes that we are all Treaty People.

Halifax is committed to strengthening its relationship with Indigenous communities and honouring the significant contributions of Indigenous peoples. Another way the municipality has demonstrated this is by

formalizing the official Land Acknowledgement: *“The Halifax Regional Municipality is located in Mi’kma’ki, the ancestral and traditional lands of the Mi’kmaq people. The municipality acknowledges the Peace and Friendship Treaties signed in this Territory and recognizes that we are all Treaty People.”*

Historically, a Land Acknowledgment is a traditional practice shared amongst Indigenous groups to recognize the Indigenous land and territory they are visiting. Now, making a respectful Land Acknowledgement remains a way to express gratitude and respect to Indigenous peoples for being stewards of the land we live and work on. It is an important step in reconciliation.

A land acknowledgment is an important statement that acknowledges we understand the long-standing history that has brought us to reside on this land and that we seek to understand our place with that history. In Nova Scotia, we are all Treaty People; with that comes roles and responsibilities.
