



DITCH TAX INFORMATION SESSIONS

In June 2022, the Province is transferring some local roads over to the municipality. In this Service Exchange, HRM will take over the responsibility of local road maintenance for all streets in Boutillier's Point, Ingramport, Head of Saint Margaret's Bay, Lewis Lake, Hubley, Upper Tantallon, East Preston, Lake Echo, Mineville, and a portion of the Lawrencetown area that is west of the Mineville Road. There will be no disruption in services to residents throughout the transfer of road and service responsibilities. HRM Staff have commenced the necessary operations and budget planning to prepare for the transfer. This work will be brought forward for Regional Council's consideration as part of the annual business plan and budget deliberations for 2022/23. Along with this road transfer, Halifax Water will be doing the stormwater management/ditch maintenance service for HRM. Hence this will bring about a Stormwater Management Service fee (Ditch Tax) to all those properties within these catchment areas. There will be Public Information Sessions held in our area:

HRM ELECTRIC VEHICLE STRATEGY

HRM's long-term climate action plan, "HalifACT: Acting on Climate Together" is the municipality's plan to reduce emissions and help communities adapt to a changing climate and to reduce carbon. HRM staff was directed to prioritize efforts in seven core areas, one being to develop a municipal electric vehicle (EV) strategy that would guide a low carbon transportation transition with recommendations relating to public EV infrastructure, policy requirements, education needs and a municipal light duty fleet transition plan. The four key areas of focus in the final EV Strategy are:

- **Public Charging Infrastructure:** a detailed plan of the number of chargers needed within the Halifax region, specific recommendations on geographical locations, and cost estimates.
- **Electric Vehicle Policies:** recommendations on municipal and provincial policies that can help increase access to home charging.

- **Advocacy and Support:** critical actions that are outside of the Municipality's direct control but for which it can advocate for, as well as educational partnerships.
- **Light Duty Fleet Electrification:** provides the Municipality with a roadmap for electrifying its light duty fleet to achieve its 100% EV target in the most cost effective and least disruptive way.

HRM & NS PROPERTY TAX PROGRAMS

HRM has programs to aid homeowners with property tax obligations. There are various options for payment plans, rebates, or deferral of property taxes. A homeowner with a LIC (local improvement charge) can apply for a deferral of these charges. Some of these programs are available to homeowners with a combined household income of \$34,000 or less. There is also a NS Provincial Property Tax Rebate for Seniors Program for those who have been receiving the Guaranteed Income Supplement in January of the application year. Criteria requires you to have paid your property taxes from the prior year in full. A receipt from HRM showing property taxes are paid in full is required. Applicants to this program can receive a rebate on half of their taxes paid to a maximum of \$800. More details can be found by calling 902-424-5200 or 211 or toll-free at 1-800-670-4357. NS HOUSING CAPACITY BUILDING

This provincial program provides funding to eligible housing providers for projects aimed primarily at supporting modernization and restructuring non-profit housing providers/co-operatives, enabling long-term sustainability. It encourages organizations to assess or reassess their operating practice and governance toward developing a plan that will achieve greater financial viability and optimize social outcomes. Organizations that demonstrate potential for growth can receive financial support to prepare development plans.
