'Serious but not dire'

394 new cases reported in province

Nova Scotia reported a record high of 394 cases on Friday when provincial officials urged people to be careful about their social activities but not to panic.

Of those cases, 295 cases are in the central zone, 54 cases are in the eastern zone, 27 cases are in the northern zone and 18 cases are in the western zone.

Seven people are in hospital, including two in ICU.

Premier Tim Houston said the symptoms appear to be less severe than previous waves, but "it's still COVID."

"Even if the symptoms of this variant do happen to be less severe, think of how your elderly parents, grandparents or neighbourhood would manage or the immunocompromised or the very young," Houston said during a news conference Friday.

"Think about what would happen if things changed and people started to get hospitalized or record numbers of health-care workers, paramedics or police started to get sick and had to isolate. Think of these things and be smart."

Some non-urgent surgeries at the QEII Health Centre were postponed due to the number of staff in isolation related to COVID-19 protocols.

On Thursday, Nova Scotia Health Authority's labs completed 7,585 tests.

"Because of a spike in testing and positive cases, public health is experiencing some delays in follow-up. Public health will try to contact anyone confirmed positive by the lab within 24 hours to provide information on required isolation and testing. All cases will be asked to contact their close contacts," the Health Department said in a news release. "We know that restrictions have their own set of significant impacts and so we are watching closely and will adjust as necessary," Strang

said. "If we need to go further or it looks like we can loosen up, we will."

Houston said St. Francis Xavier University and the St. F.X. Students' Union have been fined \$11,622.50 each for failing to comply with masking requirements under the Health Protection Act.

CHANGES COMING TO TESTING

Strang said omicron is pushing the health-care system to its limits, with public health, testing programs and the lab reaching its capacity.

"We are past the point of full control of this variant. We need to change how we manage and respond," Strang said.

Strang said the focus will be on severe illness as opposed to the overall number of cases as there will be a lot of spread of the variant.

'We can limit the impact of omicron by focusing our resources on the health system on limiting severe disease and that means directing testing and vaccines to those most vulnerable and most at risk. As long as we have limited amounts of severe illness we can be more comfortable with high cases and a fair degree of community spread," he said.

People should be careful about their social contacts, the number of people they invite for holiday gatherings (the mandated limit is 20 per household) and if you're feeling at all ill with cough or fever symptoms, isolate yourself and get a test.

of classes for public schools across Nova Scotia. Earlier this week, the Education Department announced schools will close early for the holidays after a spike in cases. Students are to return to classes on Jan. 6.

ONE-TIME BUSINESS GRANT

Many local business owners have been looking for financial aid after restrictions were reinstated across Nova Scotia on Friday. Many people have also cancelled their reservations or holiday plans at restaurants due to the rise in cases.

Houston said he's heard businesses need additional support, which is why the provincial government is introducing the sector impact support program, which will provide a one-time grant of up to \$7,500 to help small business owners in industries such as restaurants, bars, gyms, live performing art facilities and recreation facilities.

Applications will open in early January. Eligible businesses can receive the following amounts based on November 2021 gross payroll costs:

- Payroll costs between \$15,001 and \$25,000 - grant
- of \$5,000

news of the grant but said eventually more support will be needed given the massive revenue hit that restrictions will bring, particularly to the dining industry.

"It's a start and I think that's how to position it," said Gordon Stewart, president of the Restaurant Association of Nova Scotia. "This interruption is definitely going to bring a lot of pain to a lot of people with cancellations, a lot of costs, people are going to get laid off so any amount of cash and non-repayable as a grant, that would help, that's Step 1."

Stewart said a longer-term funding program to help rebuild the dining industry will be needed.

"They need to think about putting money aside to help the industry respond, it's not going to be every time we have to run back to the cash register. There (should be) a fund there we can draw on to help with education, retooling, menu building, you name all the things that are going to change the industry."

Besides money, the province should create a confidence-building campaign for the restaurant industry given the fears about indoor dining COVID has created. Stewart said the province should be talking to business owners first and getting their expert perspective before implementing restrictions on the industry.

Sue Uteck, executive director of the Spring Garden Business Area Business Association, also welcomed the grant program but said that can't be the end of the support.

"I'm very pleased with the premier's very quick response but if you break down the numbers by \$7,500, that would cover 1,330 businesses, I think. So it's a start, I want to be positive and say it's a start.'
