# SON RISEN Learning to make a living on a North Shore farm

Beyond giving thanks, for the Pearson family this has been a season of taking stock.

Of how far they've come, the work ahead and an honest reckoning with the question has it been worth it?

When you consider the sweat they've poured into 16 hectares of fallow land near River John, the family and friends they left behind in Ontario and the uncertainty still looming ahead, that's not a simple question.

Their old farm on the Northumberland Strait has demanded a steep price beyond what they paid for it.

But Son Risen Farm is all theirs.

And only a family that spent 22 years working land they could never afford themselves, and moved between nine homes over the course of raising four children, could understand what that's worth.

Jane and Andy work the farm with their adult daughters Amanda and Rachel.

"This is a venture all four of us went into together, pooling our resources," Andy Pearson said.



Saltwire visited the family the day after their arrival with their Shropshire sheep two years ago. On Thursday we checked in on their journey.

As the Nova Scotia Department of Agriculture attempts to rekindle an interest in this province's former farms and promote small-scale startups, the journey of the Pearson family to not just come but also hold fast to their dream bears lessons for many.

deemed advisable, approve the following application: Amendments to the Halifax Mainland Land Use By-law to increase front yard setbacks in the C-2C (Dutch Village Road Mixed-Use)

Zone. The C-2C Zone applies to commercial properties on Dutch Village Road, Joseph Howe Drive and Alma Crescent, in Halifax. Community Council will consider a proposal to increase the minimum front yard setback in the C-2C Zone to 1.5 metres.

A virtual public hearing will be held on Tuesday, January 18th 2022, at 6 p.m. All oral and written submissions will be considered at that time.

They came with 64 of the Shropshire ewes and rams they raise to sell as breeding stock to farms across the country. But building a financially feasible farm takes years and in the meantime there are bills to be paid.

The fields they purchased were partially grown up with alders and poplar trees. The grass there had been populated by weeds like goldenrod, plantain and buttercup (which are toxic to sheep).

That meant going in with the power saw, then hauling stumps one at a time. With that done, they tilled the land, spread manure, tilled again and then planted timothy and clover.

There was also fencing and more fencing and building small barns for the sheep.

### **CREATIVITY AND** FLEXIBILITY

"It took an adjustment period, learning how to be creative enough to make this work," Pearson said.

"I am in my late 50s and I find myself returning to some of the stuff my dad did. It's about not being so big.

"You've got smaller fields, you can't have big equipment and you can't afford it anyway.'

They've added pigs and a half-acre vegetable garden.

In Ontario the sheep would spend most of their lives inside because the price of pasture land was so high. Here they are able to raise their sheep outside on the pastures they've been developing.

That's also meant selecting breeding stock that do well outside.
