NWCC DECEMBER 13TH DISTRICT 1 UPDATE

Case 20110: Rezoning and Development Agreement for an Open Space Design Development along Windgate Drive, Beaver Bank

- Correspondence was received from 19 residents
- At the Public Hearing there were 7 speakers

Motion was put and passed:

That North West Community Council adopt the amendment to Schedule 1-C of the Land Use Bylaw for Beaver Bank, Hammonds Plains, and Upper Sackville, as set out in Attachment A of the staff report dated October 5, 2021.

Donna Boutilier, Solicitor and Andrea Lovasi-Wood, Legislative Assistant advised North West Community that the public hearing was held for both the rezoning of a portion of the property under the Land Use Bylaw and the proposed development agreement with the applicant. Community Council must first approve the rezoning and when the rezoning process is completed staff will return to Community Council for debate and decision on the development agreement.

Case 22218: Development Agreement for 32 Dutch Settlement Road, Lantz

Motion put and passed: That North West Community Council give notice of motion to consider the proposed development agreement, as set out in Attachment A of the November 3, 2021 staff report, to allow for the expansion of a salvage yard at 32 Dutch Settlement Road, Lantz, and schedule a public hearing.

Case 22670: MPS and LUB amendments to allow for industrial and highway commercial uses on the Conrad Quarry Lands, Montague Gold Mines and Waverley Motion put and passed: *That North West Community Council recommend that Halifax Regional Council:*

- 1. Give First Reading to consider the proposed amendments to the Municipal Planning Strategies (MPS) and Land Use By-laws (LUB) for Cole Harbour/Westphal, Dartmouth and Planning Districts 14 and 17, as set out in Attachments A and B of the staff report dated November 22, 2021, to allow industrial and highway commercial uses on the Conrad Quarry Lands and schedule a public hearing; and
- 2. Approve the proposed amendments to the Municipal Planning Strategies (MPS) and Land Use By-laws (LUB) for Cole Harbour/Westphal, Dartmouth and Planning Districts 14 and 17, as set out in Attachments A and B of this report, to allow industrial and highway commercial uses on the Conrad Quarry Lands.

2021 RESIDENT SURVEY



The 2021 Resident Survey was conducted between September 1 - 24, 2021. Invitations to participate were sent to randomly selected households across the municipality. The resident survey is an engagement tool used to gather information from a diverse range of municipal residents about their priorities, service experience, and expectations. The results of the survey will guide strategic and business planning and budgeting decisions and provide Regional Council and administration with valuable insight into what matters most to residents.

There were 1,766 responses to the survey. Results were provided to Regional Council on November 23, 2021.

DID YOU KNOW?

January 4th is World Braille Day.



The term 'Braille' was dubbed after its creator. Louis Braille was a Frenchman who lost his eyesight as a child when he accidentally stabbed himself in the eye with his father's awl. From the age of 10, he spent time at the Royal Institute for Blind Youth in France, where he formulated and perfected the system of raised dots that eventually became known as Braille.

Braille completed his work, developing a code based on cells with six dots, making it possible for a fingertip to feel the entire cell unit with one touch and moving quickly from one cell to the next. Eventually, Braille slowly came to be accepted throughout the world as the main form of written information for blind people. Unfortunately, Braille didn't have the opportunity to see how useful his invention had become. He passed away in 1952, two years before the Royal Institute began teaching Braille.

Braille's marvelous aid that opened up a world of accessibility to the blind and visually impaired was recognized by the United Nations General Assembly (UNGA). In November 2018, January 4 was declared World Braille Day. The first-ever World Braille Day was commemorated the following year and it was celebrated as an international holiday.

The date for the event, as chosen by UNGA via a proclamation, marks Louis Braille's birthday.

ICE SAFETY



The Halifax Regional Municipality is advising residents that it is not currently safe to be on frozen lakes and ponds as there is noticeable thin ice and open water in many lakes across the region.

The municipality's ice thickness testing program has not begun for the 2021/22 winter season as it is not yet safe for staff to be on the ice. Each year the municipality provides weekly reports on ice thickness testing undertaken on more than 70 lakes throughout the region. This testing will resume when conditions allow.

Residents are asked to take safety precautions for themselves and their families by avoiding any recreation activities on frozen lakes and ponds, including walking, ice fishing, snowmobiling, and skating until ice thickness testing resumes.

The Canadian Red Cross recommends that ice be at least 15 centimeters thick for individual skating, and at least 20 centimeters thick for group skating. Extreme caution is advised in areas where streams flow into and out of lakes. It is also important to note that ice conditions may vary over the entire surface of lakes and are subject to change with weather conditions.

hfx ALERT EMERGENCY NOTIFICATION

VOLUNTEER DURING AN EMERGENCY

In the critical hours following a crisis situation, while local and provincial response agencies are dealing with the immediate and urgent needs of the municipality, residents in affected communities need to be prepared to help themselves and to assist their neighbours, who may have been seriously impacted by the event.

Joint Emergency Management (JEM) is a concept developed by the Halifax Regional Municipality's Emergency Management Office (EMO), to allow community organizations to prepare for, and respond quickly to, a wide range of emergencies.

JEM teams are all community volunteers. In times of crises, EMO will activate JEM Support Centres (JSC) to coordinate humanitarian response to the JEM coverage area. These centres are a facility where trained individuals can meet to provide local input to

the Emergency Operations Centre, located in Dartmouth.

THE LEDWIDGE BRIDGE




Nova Scotia Off Road Riders Association:

WINTER DRIVING

With winter weather arriving soon to our region, Halifax Regional Police is sharing some winter safety tips to help road users be winter ready.



Vehicle maintenance

Plan ahead to ensure your vehicle is roadworthy.
Check your safety inspection sticker and the
tread on your tires. Keep a snowbrush or ice
scraper in your vehicle and consider topping up
your vehicle with extra windshield washer fluid.
It's also a good idea to have a shovel and/or a
bag of salt or sand in your vehicle in case you get
stuck.

Driving safely for the road conditions

- Stay up-to-date with the weather conditions.
- Visibility is key. Before you hit the road, clear all snow from the roof, hood, license plate, windows,

- mirrors, lights, turn signals and cameras of your vehicle. Scrape/defrost your windshield if necessary.
- Be mindful that winter conditions create challenges for pedestrians who may need to walk in the roadway to avoid snow-covered or icy sidewalks.
- Never drive distracted. Keep your hands on the wheel and your eyes on the road. Watch for other road users, pedestrians and cyclists.
- Adjust your speed to the conditions. Leave extra space between you and the vehicle in front of you so that you can safely slow down and/or stop. Remember not to accelerate or brake too quickly when the roads are slippery.

Parking

- Think before you park on the street. When and where you park in the winter can have a big impact on clearing streets and sidewalks, which, in turn, can affect road safety.
- In Nova Scotia, vehicles can be towed at any time during the day or night on any day of the year if they are interfering with snow clearing operations, as per Section 139 of the Nova Scotia Motor Vehicle Act. In addition, the municipal overnight winter parking ban is in effect every year from Dec. 15 to March 31. It will be enforced only during declared weather events and ongoing clearing operations. When enforced, the parking ban is in effect from 1 a.m. until 6 a.m. throughout the Regional Centre of the municipality. To learn more, visit:
