BACKGROUND

While developing their 2022 Work Plan, the Women's Advisory Committee agreed to address climate change.

The Women's Advisory Committee received a presentation from Emma Norton, Director of Government Relations and Atlantic Canada Organizing, Climate Emergency Unit on climate emergency¹ at their January 13, 2022 meeting. The Committee sought a presentation from HRM staff on HalifACT at their February meeting.

The Women's Advisory Committee received a staff presentation on HalifACT² at their February 3, 2022 meeting. The Committee deferred discussion on possible actions in response to the climate emergency presentations to their March meeting.

DISCUSSION

The Women's Advisory Committee discussed the information received from the presentations at their March 3, 2022 meeting, noting their full support for HalifACT, and approved the recommendation to the Executive Standing Committee as outlined in this report.
