SUPPLEMENTARY REPORT

ORIGIN

December 13, 2021 Board of Police Commissioners motion (Item 10.1.3):

MOVED by Commissioner Critchley, seconded by Commissioner Kent

THAT the Board of Police Commissioners approve the first three dates in the proposed Board of Police Commissioners 2022 meeting schedule as outlined in the staff memorandum and request a staff report to provide further information relating to timing and financial implications of changing the meeting schedule.

MOTION PUT AND PASSED.

March 21, 2022 Board of Police Commissioners motion (Item 7.1):

MOVED by Commissioner Blackburn, seconded by Commissioner McDougall

THAT the Board of Police Commissioners approve the proposed 2022 meeting schedule until June 2022 as outlined in Attachment 1 of the February 7, 2022 staff report.

MOTION PUT AND PASSED.

LEGISLATIVE AUTHORITY

The *Police Act*, 2004, S.N.S. 2004, c. 31, section 49, states:

49 The board must hold a board meeting at least every three months.

RECOMMENDATION

It is recommended that the Board of Police Commissioners approve the proposed meeting schedule for July to December 2022 as outlined in Attachment 1 of this report.

BACKGROUND

In accordance with Section 49 of the *Police Act*, the Board of Police Commissioners (the Commission) shall:

"meet no less than once every three (3) months, preferable monthly, or as determined by the Commission."

At the Board's December 13, 2021 meeting it was noted that the Commission may wish to change its current meeting day and time, the third Monday of the month from 12:30 p.m. to 3:30 p.m., to accommodate the schedules of volunteer Commissioners and improve public engagement. The Board requested a recommendation report outlining the options for the Commission to schedule its regular monthly meetings outside of normal working hours including a jurisdictional scan of Police Boards' meeting schedules and the financial implications associated with evening meetings.

Staff submitted a report to the Commission's March 21, 2022¹ meeting that included the requested jurisdictional scan and recommended that the Commission approve a meeting schedule until June 2022 which maintained the status quo meeting day and time. During this time the Office of the Municipal Clerk would poll individual members for their preferred meeting date and time. A follow up report would be provided in May, with an attached meeting schedule for the remainder of the year based on this feedback. At the Board's March 21, 2022 meeting the Commission noted the follow up report would benefit from a survey of the community regarding day and time of in-person meetings, hybrid meeting options, a survey of other jurisdictions regarding the livestreaming of in-person meetings and information regarding the use of Council Chambers to allow for the livestreaming of in-person meetings. This report provides the results of a jurisdictional scan of Police Boards and polling of Halifax Board of Police Commissioners. A community survey may be included in additional reviews but could not be completed with the timing available for this report.

DISCUSSION

The *Police Act*, in sections 44(4) & 57(4) requires that the Commission consist of seven members: three members of council appointed by resolution of the council; three members appointed by resolution of the council, who are neither members of council nor employees of the municipality; and one member appointed by the Provincial Minister of Justice.

Further to the Commission's direction, an email poll was conducted to determine each commissioner's ranking of the four following choices for a preferred meeting day and time:

Option #1 – First Wednesday of the month, 12:30-3:30 p.m.

Option #2 – First Wednesday of the month, 4:30-7:30 p.m.

Option #3 – Third Wednesday of the month, 12:30-3:30 p.m. (Current meeting day and time)

Option #4 – Fourth Thursday of the month, 4:30-7:30 p.m.

The email poll also allowed commissioners to indicate if any option posed a scheduling conflict. Responses were received from six of the Commission's seven commissioners (Attachment 2). Of the responders, one Commissioner indicated they are available for all meeting options. Accordingly, this Commissioner was not

included in the ranking. A second Commissioner indicated that their first and second preference was for Option #4 (fourth Thursday at 4:30 p.m.). Option #4 was counted as this Commissioner's first choice only. This Commissioner also indicated that their third and fourth preferences was for Option #2 (first Wednesday of the month at 4:30 p.m.), thus Option #2 was counted as their third choice only. Accordingly, no vote for the meeting options #1 or 2 were logged for this Commissioner.

The results of the meeting day and time poll indicate that the first Wednesday of the month starting at 12:30 p.m. (Option #1) was the first preference of two commissioners, the second preference of one commissioner and the third preference of one commissioner. Option #1 has the additional benefit of not being indicated as a scheduling conflict for commissioners.

The fourth Thursday of the month starting at 4:30 p.m. (Option #4) was also the first preference for two commissioners. However, this option was specified to be a scheduling conflict by two commissioners and cannot be considered a viable option due to the importance of maintaining quorum. A quorum of members is essential to hold a procedurally valid meeting that can approve a meeting agenda and vote on motions. Section 50 of the *Police Act* indicates that a majority of police commission members constitutes quorum. The Commission's quorum is five. Thus, a meeting day and time that is indicated to be a scheduling conflict for two of the seven commissioners is a substantial risk to maintaining quorum for the Commission's monthly meetings.

The Commission's current meeting day, the third Monday of the month beginning at 12:30 p.m. (Option #3) was the first preference of one commissioner, the second preference of two commissioners and the fourth preference of one commissioner. The Commission's current meeting day also has the additional benefit of not being indicated as a scheduling conflict for commissioners. The first Wednesday of the month starting at 4:30 p.m. (Option #2) was not a first preference for any commissioner, the second preference for one commissioner, the third preference for two commissioners and the fourth preference for one commissioner. Option #2 was also expressed to be a scheduling conflict for one commissioner.

Staff recommends that the Commission select the first Wednesday of the month from 12:30-3:30 p.m. as the Commission's meeting day and time for the remainder of 2022 beginning with its' July meeting. This meeting option was preferred by most commissioners and was not expressed to be a scheduling conflict.

A community survey to determine preferences regarding the timing of in-person Commission meetings was not possible during the two-month period allowed for this report's preparation. A survey can be completed prior to the preparation of the 2023 Board of Police Commissioners meeting schedule.

The Office of the Municipal Clerk also conducted a survey of Police Boards to determine their use of virtual meetings and livestreaming. This survey also included questions relating to public engagement as the Commission identified the improvement of public engagement in their original request for a staff report into the Commission's meeting schedule. Six Police Boards responded to this survey (Attachment 3). The Halifax Board of Police Commissioners is included in this summary of survey results to allow for comparison.

Survey results indicate that two Police Boards are still holding virtual meetings exclusively. The York Region Police Services Board may consider a hybrid model for future meetings, but they have not determined the format of a possible hybrid meeting option. Two Police Boards continue to meet virtually and have begun or will begin using a mix of in-person or virtual meetings. Three Police Boards have resumed in-person meetings. The Ottawa Police Services Board's in-person meetings do not allow for virtual participation. Any public presenters who cannot appear in-person can make written submissions to the Board. The Winnipeg Police Board may meet virtually if required due to time constraints or a high community incidence of COVID 19.

Five Police Boards livestream their meetings. The three Police Boards that have resumed in-person meetings are able to livestream these in-person meetings.

With respect to public engagement, all six Police Boards allow for members of the public to make a delegation or presentation on general matters within the Board's jurisdiction at their monthly meetings. All six Police Boards require that written requests to present be submitted prior to the meeting. Presentation speaking time limits range from four minutes, five minutes and ten minutes with five minutes used by three of the six Boards surveyed. See Attachment 3 for more details regarding registration requirements and speaking time limits.

The Winnipeg Police Board also allows for the public to register to speak regarding a specific agenda item. Requests to speak must be submitted in writing and be received by 1 pm the business day before the meeting. Members of the public who attempt to register to speak after the deadline can make a written submission or submit a request to present at the next regular meeting. The Winnipeg Police Board limits the number of delegates that can speak in support or in opposition to an agenda item to a maximum of two per position.

The Calgary Police Board allows for two forms of public participation at the meetings. The request to participate must relate to a matter of police governance and oversight. Members of the public can request to make a verbal presentation and speak for up to four minutes followed by time allowed for clarification questions. Members of the public can also request to ask a verbal question. People are encouraged to submit their questions in advance of the meeting. During the meeting a person is allowed up to two minutes to ask a question, with two minutes provided for the Chair or a designate to answer. This public participation is limited to a maximum of five speakers per meeting.

FINANCIAL IMPLICATIONS

When scheduling meetings, staff availability must be considered. Meetings require staff support as well as participation in order to occur. Staffing models will need to be developed if an alternative meeting schedule, additional meetings or meetings outside of standard meetings hours are going to be consistently held.

ALTERNATIVES

The Commission could choose Option #3 – Third Wednesday of the month, 12:30-3:30 p.m. (which is the Commission's current meeting day and time) because this was the second preferred option, which did not also pose a scheduling conflict for commissioners.
