STRATEGIC PERFORMANCE SNAPSHOT

The Halifax Regional Municipality has launched its Strategic Performance Snapshot (SPS) – a new online dashboard showcasing the municipality's progress as it delivers on the priorities of Regional Council and the administration.

The new online tool is a 'snapshot' in time based on data that is updated annually. The goal is to improve access to information through a centralized dashboard that shows how well the municipality is delivering services. Some of the key features of the dashboard include year-over-year trends, information about related Key Performance Indicators (KPIs), and at-a-glance graphs and charts. Members of the public can also access data on more than 80 municipal projects and initiatives.

VOLUNTEER SEARCH & RESCUE GRANTS PROGRAM

Regional Council recently awarded operating grants for the Volunteer Search and Rescue Grants Program. This included \$19,990 for the Musquodoboit Valley Ground Search and Rescue.

RURAL TRANSIT FUNDING

The MusGo rural transit service will be receiving two grants from our Rural Transit Funding program. Regional Council approved \$140,000 for MusGo Musquodoboit and \$67,500 for MusGo Valley-Sheet Harbour.

INVESTMENTS IN DISTRICT 1

The **District Capital** fund provides larger grants to non-profit organizations for both capital and operating expenses that will benefit the community and can also be used to support HRM capital projects. The **District Activity** fund allows Councillors to support non-profit groups with events or initiatives that benefit their community with small grants.

COMMUNITY GRANTS IN DISTRICT 1 FOR 2022/2023

Musquodoboit Valley Bicentennial Theatre & Cultural Centre: A capital grant in the amount of \$21,500 to fully fund the purchase of a sound and lighting system for the Bicentennial Theatre.

Icelandic Memorial Society of Nova Scotia - Markland **Settlement:** A project grant in the amount of \$2,500 for settlement site interpretation.

Waverley Community Association – Waverley: A grant in the amount of \$4,000 to establish video conferencing/ presentation capability.

LWF Firemen's Association - Lakeview/Windsor **Junction/Fall River:** A capital grant in the amount of \$6,000 towards the purchase and installation of a replacement furnace.

Royal Canadian Legion: Valley Branch #147 - Upper **Musquodoboit:** A grant in the amount of \$10,000 towards the purchase and installation of two heat pumps. The applicant will be referred to the provincial government's Legion Capital Fund for the balance required.

Scotia XC Ski Club - Meagher's Grant/Regional: A grant of \$6,000 towards the purchase of trail grooming equipment for cross-country skiing. Holdback pending confirmation of equipment storage and insurance coverage.

Wellington Fletcher's Lake Station House Community Hall - Oakfield: A grant in the amount of \$10,000 towards a septic system replacement

Arthur Kidston Memorial Camp – Middle Musquodoboit A grant in the amount of \$3,690 to fully fund the purchase of six kayaks and paddles.

LWF Hardball Association/Grand Lake Oakfield Community Association: A capital grant in the amount of \$7,500 is recommended towards the purchase of a batting cage and fencing for the Grand Lake Oakfield Community Association's baseball field.

- Case 21460 Site C in Fall River/Ingram Drive
 KWR Approvals have applied for a site-specific
 amendment to the River-Lakes Secondary Planning
 Strategy (SPS) to develop 3 multiple unit buildings,
 3 stories high at the end of Ingram Drive. The proposed
 development will include 120 dwelling units with 60%
 open space and a provision for a future connector trail
 to the MacDonald Sports Park. Traffic and Phosphorus
 Net Loading assessments will be required to verify the
 suitability of the development. The second round of
 community consultation is now complete and a report is
 being prepared for North West Community Council and
