Halifax Regional Council intend to consider and, if deemed advisable, approve the following application:

Case H00527 - An application by ZZap Consulting Inc., on behalf of Galaxy Properties Limited, to substantially alter the contributing heritage resource at 5185-89 South Street, Halifax (known as the Elmwood). The applicant is proposing to remove the building's rear wing, construct a modern 9-storey addition, and rehabilitate the original Elmwood structure. The public hearing is required in accordance with the Old South Suburb Heritage Conservation District By-law (Bylaw H-800).

The public hearing will be held on **Tuesday, July 12, 2022 at 6:00 p.m.** at Halifax City Hall (Council Chamber), 1841 Argyle Street, Halifax, NS. NOTICE OF SECOND READING BY-LAW R-109, RESPECTING THE REPEAL OF BY-LAWS AND ORDINANCES

TAKE NOTICE that the Council of the Halifax Regional Municipality will consider the adoption of By-law R-109 at a meeting of Regional Council to be held on **Tuesday, July 12, 2022** in the Halifax Council Chamber, 1841 Argyle Street, Halifax.

By-law R-109 will amend By-law R-100 Respecting the Repeal of By-law and Ordinances. The purpose of the amendment is to repeal By-law P-800, the Pesticide By-law, which will be replaced with an Integrated Pest Management Strategy. If the By-law is repealed, pesticide regulation will fall under the existing *Non-essential Pesticides Control Act* of 2010, which is administered by the Nova Scotia Department of Environment and Climate Change under the Environment Act. As such, repealing By-law P-800 is a matter of administrative housekeeping to align HRM policy with that of the Province, and will not impact the availability and use of non-essential pesticides.

The Council will receive written submissions from interested persons concerning the above by-law at the **July 12, 2022** session of Council. **Written submissions must be received by the Municipal Clerk's Office no later than 9:00 a.m. on the advertised date.** Written submissions may be forwarded to the Municipal Clerk by email, clerks@halifax.ca, by fax, 902-490-4208; or by mail, P.O.
