## NOTICE OF APPROVAL BY-LAW R-109, RESPECTING THE REPEAL OF BY-LAWS AND ORDINANCES

**PUBLIC NOTICE** is hereby given that By-law R-109, Respecting the Repeal of By-laws and Ordinances was adopted by Halifax Regional Council on July 12, 2022.

By-law R-109 amends By-law R-100, Respecting the Repeal of By-laws and Ordinances. The purpose of the amendment is to repeal By-law P-800, the Pesticide By-law, which will be replaced with an Integrated Pest Management Strategy. If the By-law is repealed, pesticide regulation will fall under the existing *Non-essential Pesticides Control Act* of 2010, which is administered by the Nova Scotia Department of Environment and Climate Change under the Environment Act. As such, repealing By-law P-800 is a matter of administrative housekeeping to align HRM policy with that of the Province, and will not impact the availability and use of non-essential pesticides.

Halifax Regional Municipality (HRM) will be hosting an Open House and Public Meeting on Tuesday, July 19, 2022 at 6:00pm at the Upper Hammonds Plains Community Centre - 711 Pockwock Rd, Upper Hammonds Plains, NS. HRM has heard concern from members of the Upper Hammonds Plains community about some new businesses and buildings that have appeared in the community in recent years. Concerns are about conflict between uses on properties, inadequate screening/buffering between uses and buildings, distances between residential and commercial/industrial activities, and lack of community consultation for large development proposals. As a result, Council has asked planning staff to review the land use policies and regulations for the area and invite input from residents and land owners in the community.

This Open House and Public Meeting is to introduce HRM Staff, share the results of the What We Heard Survey Report, and to receive your feedback. Please join us and let us know what types of land uses you would like to see in your community in the future and share with us your ideas for the future development of your community!
