





1. Age



- Part of an intact heritage streetscape constructed by wealthy merchant families through the mid-to-late 19th century.
- Originally owned and constructed by merchant John C. West in 1862.
- Property stayed in the West Family until 1888.
- Members of the West family constructed several residences along Brunswick Street.


2. Historical or Architectural Importance



John C. West and the West family

- Merchant; one of the sons of John Conrade West (Sr.) who founded the C. West West Indies merchantry business
- Owned three wharves on the Halifax Harbour and were considered a prominent merchant family


2. Historical or Architectural Importance



Sisters of Charity of St. Vincent de Paul

- Purchased by Sisters of Charity in 1888 and became the new St. Patrick's Convent
- Sisters of Charity are known for later staffing the Shubenacadie Indian School from 1930-1967

2. Historical or Architectural Importance



Architectural Importance

- Highly representative of residential Italianate architecture
- Defined by characteristics such as symmetrical front fascia, paired roundheaded windows, among others.
- Unique due to rare brick and stucco use, where most residential Italianate architecture in Halifax is wood construction

3. Significance of Architect / Builder


- The West family was known to have employed architecture firms for other residences on Brunswick Street, and had familial ties to Edward Elliot
- Historical research did not identify a specific architect or builder for 2287 Brunswick Street




- Brick construction with façade covered in stucco


