- **1**. The funds are to be used for the purchase of insurance by the Community Rink Group for the Community Outdoor Rink.
- 2. The Community Rink Group will be required to submit the actual receipt showing proof and amount of payment.
- 3. Any funds not spent by the Community Rink Group for insurance are to be returned to the Municipality.

Failure to comply with the conditions of the grant may result in ineligibility for any such grant in the following year.
