

How To: Food Vendor License Application

All food vending locations, not awarded through the Vendor 5 Year program, are available for seasonal food vendor licenses. In addition, bicycle vendors move from site to site so there are no vending locations available to be chosen.

1. From the Home page of the Customer Portal, select Apply for or Renew Licenses.







2. Select the Vendor – Food license type.



3. Enter the requested Activity Start Date – this is any time through the year. The Vending – Food licenses expire on December 31 of the year in which they are issued. Click Next.
