

How To: Vehicle for Hire – Broker / TNC License Application

A Broker / Transportation Network Company (TNC) license is renewable yearly. The TNC license fee is based on the number of vehicles being utilized. Should the number increase or decrease throughout the year, applicants can submit an Amendment that may change the license fee for the remainder of the license year.
