

Vehicle for Hire – Permanent Driver License Application

Once all the conditions within the Conditional Driver License have been met within the **one-year** *time limit*, applicants can apply for their Permanent Vehicle for Hire Driver.

1. From the Home page of the Customer Portal, select Apply for or Renew Licenses.



2. Under Vehicle for Hire, select the Vehicle for Hire - Driver - Permanent license type.





3. Enter the requested Activity Start Date.



4. Choose an Existing Business or create a New Business (for more information on this process see the job aide).



5. Enter your Conditional Driver License number. Click Next.
