# **Policy Goals**

- Accountability
- Accessibility

## Reasons for Change

- Alignment to Municipal organizational structure.
- Apply more focus on authority, trade agreements and legislation.
- Mitigate financial and legal risks.
- Enable more efficient procurement strategies.
- Continue to support Living Wage initiatives.
- Reflect feedback from internal and external stakeholders.

### **Definitions**

- New roles and titles include:
  - Deputy CAO
  - Executive Director
  - Director
- Auditor General is subject to Trade Agreement constraints but does not report to CAO.
- Gender neutral pronouns.

# **Pre-Requisites to Award**

 Wording now aligned with requirements of Section 79A of Halifax Regional Municipality Charter.

 Expenditures made in any given fiscal year must explicitly be provided for in operating or capital budgets with limited exceptions.

## Rationale for Proposed Award Authorities

- Council approves annual capital and operating budgets and multi-year capital plans prior to issuance of solicitations.
- Will reduce time from posting to award by 3 or more weeks for higher value contracts, and up to a week for under \$1M.
- Increases accountability and streamlines administrative processes.
- HRM has limited discretion to by-pass low bid/highest score.
- Mitigates risk of political influence in the award process experienced in other jurisdictions.
- Councillors will continue to receive weekly/quarterly award lists.

#### **Contract Amendments**

- Existing process delays necessary changes to projects in process.
- Often include public and environmental safety considerations and stopping work is often unrealistic and increases costs.
- Must be fully funded within the project budget, fully documented and reported to the Audit & Finance Standing Committee.
- CAO may choose to direct approval to Regional Council.

## **Cost Sharing Agreements**

- Third-party funding must be confirmed prior to award.
- Approval limits match other authorities.
- Except from Halifax Water, third-party funding which increases approved scope or budget
   \$1M must be approved by Council.

## **Other Authorities**

#### **Options and Terminations**

- Options are already considered in the original contract.
- Termination requires consultations with Legal Services and Procurement.

#### **Contract Assignments and Assumptions**

- Mostly due to acquisitions or mergers.
- Does not impact the original contract requirements.

#### **Exemptions**

- Clarification of responsibility based on Charter.
- Recognizes Chief Financial Officer authority to pay bills.



## **Living Wage – Source Change**

- Staff cannot currently update Living Wage
- Living Wage Canada directly links to CCPA
- CCPA is the original source of Living Wage data
