<u>ORIGIN</u>

Staff originated report.

LEGISLATIVE AUTHORITY

Police Act. 2004, S.N.S 2004, c. 31, section 49, provides:

49 The board must hold a board meeting at least every three months.

RECOMMENDATION

It is recommended that the Board of Police Commissioners approve the revised 2023 meeting as outlined in Attachment 1 of the staff report.

BACKGROUND

On December 14, 2022 the Board of Police Commissioners (BoPC) approved its 2023 meeting schedule with Halifax Hall, 2nd Floor City Hall, 1841 Argyle Street, Halifax listed as the Board's in-person meeting location. On February 6, 2023 the BoPC approved a revised 2023 meeting schedule which changed the BoPC's in-person meeting location to the Harbour East Marine Drive Community Council (HEMDCC) Meeting Space, Main Floor Alderney Landing, 60 Alderney Drive, Dartmouth.

A staff report entitled "Budget Process Refresh and Board Policy Update", will be tabled at the Board of Police Commissioners (BoPC) August 2, 2023 meeting. This staff report recommends that the BoPC adopt a schedule for the BoPC's review of Halifax Regional Police's annual budget. The proposed budget review schedule includes additional meetings to be added to the Board's approved meeting schedule.

DISCUSSION

The "Budget Process Refresh and Board Policy Update" staff report proposes that the Board of Police Commissioners (BoPC) schedule two public participation meetings to continue the BoPC's practice of including members of the public in the Halifax Regional Police (HRP) budget process. It is proposed that the two public participation meetings (one virtual one in person) be scheduled outside of the BoPC's regular monthly meetings and be scheduled in October and November (See Attachment 1).

The revised 2023 meeting schedule includes other modifications meant to provide a consistent time and location for meetings as well incorporate feedback heard since the Boards move to the Harbour East Marine Drive Community Council meeting space. The meeting start time is changed to 4:00 p.m. to allow for consistency and predictability because the existing meeting schedule has the meeting start time alternate every month, with either a 12:30 p.m. or 4:30 p.m. start. The meeting length is increased from three to four hours as BoPC meetings regularly run over time to complete the meeting's agenda and often include the deferral of items to future meetings. The proposed 4:00 p.m. to 9:00 p.m. meeting will include a 30-minute supper break.

The BoPC currently meets monthly on the first Wednesday of the month. Given the BoPC's increasing workload, including an earlier review of HRP's 2024/25 operating budget, it is recommended that an additional monthly meeting be scheduled as a contingency, beginning in September. The review of HRP's 2024/25 operating budget also includes two public participation meetings in October and November, one public participation session will be held in-person and the other will be held virtually to accommodate the needs of the public.

ALTERNATIVES

The Board of Police Commissioners could suggest an alternative meeting schedule. Meeting times and locations can be modified through the Agenda Review process and may be held virtually.
