

# HALIFAX NEW VEHICLE FOR HIRE (TAXI/LIMOUSINE) DRIVER

---

The following steps are required to become a vehicle for hire (taxi/limousine) driver:

**Step 1. Pass an English Language Test through one of the following organizations:**

- East Coast Language College 902-491-1526
- Language Assessment Services of NS 902-431-8879

*Applicants who may have a concern with either their driver abstract or criminal record report, should submit an inquiry to the taxi office by emailing [licensing@halifax.ca](mailto:licensing@halifax.ca) prior to attempting English language testing.*

**Step 2. Vehicle for Hire Application Submission:**

Submit application at one of the two Customer Service Centres:

**Step 3. Driver Knowledge Exams (pass mark 70%):**

**Upon approval of the complete Vehicle for Hire Application the Taxi Office will contact applicant regarding testing for the following three exams:**

*On successful completion of steps 1, 2 & 3 applicants will be eligible to register for the National Certification Program.*

**Step 3. Registration for National Certification Program for Taxi/Limousine Drivers:**

To receive a one year conditional driver licence you must provide proof of registration for the program.

*You will have 12 months to complete the National Certification Program, failure to do so will result in your conditional licence being terminated.*
