ANS Road to Economic Prosperity (REP)

- 2018-2020, REP Action Plan owned by ANS Communities in conjunction with Halifax Partnership.
- 30 actions endorsed by HRM Regional Council in Sept 2020.

- Build community capacity and mobilization.
- Increase collaboration between ANS communities and partners.
- Address issues related to land ownership & environmental racism.

- Revitalize & invest in ANS communities
- Increase ANS labour force

REP Actions: HRM

Many of the actions in REP's plan are HRM-specific:

12. Explore Community Benefits Agreements in ANS communities

13. Identify and address legislation and land use bylaws that impact ANS communities

16. Review the naming, boundaries, and zoning of historic ANS communities, and zoning affecting ANS communities

Beechville

- 2017: ANS community of Beechville deeply upset with new development displacing historic residents.
- HRM directed staff to work with Beechville to address immediate planning concerns.
- Beechville requested a long-term project by staff to address historical concerns.

Beechville

- 2019-2020: Beechville builds a **Strategic Plan** that outlines challenges and opportunities.
- HRM staff created a **Community Action Plan** to address items that are in the municipality's jurisdiction.
- Long-term planning in Beechville from 2017present.

BCDA Quality of Life/Recreation

Mandate

To: create opportunities for healthy, cultural, leisurely and educational experiences for all residents, descendants and adherents of the Beechville Community as part of the 1-5-year plan/s.



To: identify possible opportunities funding, resources and partnerships related to quality of life and recreation



African Nova Scotian Community Action Program (ANSCAP)

- REP and Beechville highlighted the need for longterm planning in ANS communities.
- ANSCAP established in October 2023 to begin community action programing in other ANS communities.
- Currently team of 2, expanding to 5 throughout 2024.

Community Strategic Plan (REP)

- Community-led process aided by REP.
- Community builds capacity and organizes itself to address challenges.
- Residents identify strengths and weaknesses and develop a multi-year strategy to address them.
- Strategic Plan developed and formalized by the community.

Community Action Plan (ANSCAP)

- HRM takes the community Strategic Plan and identifies actions under its jurisdiction.
- Confirms actions with community and identifies other projects that HRM can help develop.
- Actions are organized by priority with community and established into a Community Action Plan.
- HRM writes **Staff Report** to formalize Community Action Plan

Community Action Plan

- Actions are organized by department.
- Nearly every department in HRM could have actions
- ANSCAP will be responsible for tracking actions and advocating internally for their completion
- ANSCAP regularly updates and takes direction from community.

2 Steps to Community Action Planning

Planning Actions

- Municipal Planning Strategy and Land Use Bylaw Review (MPS & LUB)
- Community Boundary Review
- Heritage Commemoration
 and Conservation.

Municipal Actions

- Transit Routes and Services
- Infrastructure and public works (paving roads, crosswalks, sidewalks, etc.)
- HRM Land Transfers to Community organizations
- Environment & Climate Action

Next Steps

- Beginning community action planning with Upper Hammonds Plains.
- Early conversations with Lucasville and East Preston (awaiting Strategic Plan).
- Hiring has started for more planners in the ANS Planning Team.
- Regular check-ins with communities as the program evolves.
