Current Economic Context

- Restrictions have ended, but COVID has resulted in societal shifts.
- Housing availability and affordability, inflation, and interest rates are affecting residents and businesses.
- Labour availability still a concern for employers; productivity stats remain low in Nova Scotia.
- Major projects continue to benefit Halifax's economy.
- International issues are contributing to inflationary pressures and heightening export risks.
- Impacts of climate change require focused attention.
- Positive GDP growth is forecasted.
- Population growth still needed for demographic challenges and labour market needs.

Engagement

Who:

- Primarily with Halifax Partnership and HRM departments responsible for implementation.
- Partners who support implementation (Discover Halifax, ANSREP, BIDs, Chambers/Business Associations).

What We Heard:

- Progress on Integrated Tourism Master Plan and ANS Road to Economic Prosperity has increased interest in other actions in the economic strategy.
- BIDs and Halifax Chamber are still aligned on strategy; advocating for HRM-specific initiatives.
- Engagement with suburban and rural Chambers/Associations is ongoing.

Years 3-5 Actions & Measurement

- 60 Actions for Years 3-5
 - 17 led by Halifax Partnership
 - 38 led by HRM
 - 5 co-led
- Many actions remain unchanged, and implementation continues.
- 3 actions are complete.
- Several actions have minor wording updates.
- Some actions were removed, and others combined.
- 3 actions are new.
- Measurement metrics remain appropriate and are unchanged.
